JUNE 26, 2009 JOINT REPORT ON STATUS OF CLOSING THE UNWIND TRANSACTION

The applicants ("<u>Applicants</u>") Big Rivers Electric Corporation ("<u>Big Rivers</u>"), E.ON U.S. LLC ("<u>E.ON US</u>"), Western Kentucky Energy Corp. ("<u>WKEC</u>") and LG&E Energy Marketing, Inc. ("<u>LEM</u>," and collectively with E.ON US and WKEC, the "<u>E.ON Parties</u>") make this status report filing, through counsel, to comply with the ordering paragraph number three of the March 6, 2009 Order of Public Service Commission ("<u>Commission</u>") in this matter.

The information contained in this Report reflects the more significant developments in the closing activities from the June 4, 2009 Report on Status of Closing the Unwind Transaction through June 26, 2009.

Outstanding Issues related to Closing

At the June 3, 2009 Informal Conference, the parties, attending in person or by phone, agreed to attend an informal conference on June 16, 2009 at 9:00 a.m. ESDT for the purpose of discussing the outstanding issues related to the closing. At the June 16, 2009 Informal Conference, the parties and Southwire Company met without the participation of the

Commission Staff or the Attorney General and negotiated the resolution of the outstanding issues related to closing. The results of the negotiations were presented in separate meetings with the Commission Staff, Attorney General, Southwire Company and all the parties to the case. At the June 16, 2009 Informal Conference in this proceeding, E.ON U.S. LLC presented the terms to its agreement with Century Aluminum Company. At the conclusion of the presentation, Commission Staff requested E.ON U.S. LLC to provide an illustrative example of the billing calculations for this agreement. E.ON U.S. LLC filed this information with the Commission on June 19, 2009.

As a result of the negotiations during the June 16, 2009 Informal Conference, the parties and Southwire Company informed the Commission Staff and the Attorney General that they had reached an agreement in principle on all the outstanding issues necessary for the closing of the Unwind Transaction, including the agreement of Century Aluminum to proceed with the transaction, the consent of Southwire Company to the transaction and the resolution of the outstanding issue between Big Rivers Electric Corporation, and the City of Henderson, Kentucky and the City of Henderson Utility Commission d/b/a Henderson Municipal Power & Light.

Since the June 16, 2009 Informal Conference, the parties have worked diligently to complete the final documents reflecting the resolution of the outstanding issues. On June 24th and 25th, 2009 Big Rivers filed documents with the Commission in this proceeding. On June 25, 2009, Kenergy Corporation filed the agreements related to the retail service of Southwire Company with the Commission. E.ON U.S. LLC is planning to file the documents related to the agreement with Century Aluminum, the consent of Southwire Company and other documents with the Commission by email and overnight courier on June 26, 2009.

Through the exchange of emails between E.ON U.S. LLC and Commission Staff and the parties to the case, an informal conference is to be scheduled for Thursday, July 2, 2009 at 1:00 p.m. for the purpose of reviewing the documents and the illustrative billing calculation, receiving an update on the status of the credit ratings of Big Rivers and answering any questions.

Investment Grade Credit Ratings

During the week of June 22, 2009, Big Rivers and E.ON U.S. LLC met with Moody's Investor Services, Standard and Poor's and Fitch Ratings to review the status of the Unwind transaction and specifically the agreement between E.ON U.S. LLC and Century Aluminum. Big Rivers anticipates favorable investment grade reviews will be issued by these credit rating agencies.

Rural Utility Service

Big Rivers has continuously kept the United States Department of Agriculture Rural Utility Service ("RUS") informed of the status the negotiations of the Unwind transaction and the Commission's review in this proceeding and provided with information and documents associated with the transaction. RUS is presently reviewing the transaction and is aware of Big Rivers' interest in closing the transaction on July 8, 2009.

Closing Date

E.ON U.S. LLC and Big Rivers continue to use July 8, 2009 as the target date for the closing of the Unwind Transaction.
