## ORDER

On March 31, 2000, the Commission issued its Order in Case No. 1999-00225<sup>1</sup> approving certain adjustments to the rates of Citipower, LLC ("Citipower") and providing under certain conditions for the further adjustment of such rates in accordance with the provisions of Citipower's Gas Cost Adjustment ("GCA") clause.

On October 29, 2007, Citipower filed its GCA to be effective December 1, 2007.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Citipower's notice proposes revised rates designed to pass on its expected change in gas costs to its customers.
- 2. Citipower's proposed Expected Gas Cost ("EGC") is \$10.44 per Mcf, which is no change from the prior approved EGC of \$10.44.
  - 3. Citipower's notice sets out no refund adjustment.

- 4. Citipower's notice sets out a current quarter Actual Adjustment ("AA") of \$.0704 per Mcf. Citipower's total AA is (\$.7666) per Mcf, which is an increase of \$.3229 per Mcf from the previous total AA.
- 5. Citipower's notice sets out a current quarter Balance Adjustment ("BA") of \$.1317 per Mcf. Citipower's total BA is \$.1191 per Mcf, which is an increase of \$.0885 per Mcf from its prior total BA.
- 6. These combined adjustments produce a Gas Cost Recovery rate of \$9.7925, which is \$.4114 per Mcf more than the previous rate of \$9.3811.
- 7. The revised rates in the Appendix to this Order are fair, just and reasonable, and should be approved for billing for service rendered on and after December 1, 2007.

#### IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are fair, just, and reasonable, and are approved for billing for service rendered on and after December 1, 2007.
- 2. Within 20 days of the date of this Order, Citipower shall file with the Commission its revised tariffs setting out the rates authorized herein.
