MOTION TO CANCEL HEARING AND TAKE CASE UNDER SUBMISSION

Bluegrass Wireless LLC ("Bluegrass Wireless"), by counsel, hereby files its motion to cancel hearing and take case under submission based on the existing written record. In support of its motion, Bluegrass Wireless states as follows.

Pursuant to the July 9, 2008 Order (the "Order") of the Public Service Commission of the Commonwealth of Kentucky (the "Commission") in the above-referenced matter, the Intervenors had ten days, until July 19, 2008, to notify the Commission in writing of their intent to participate in the hearing scheduled for August 27, 2008 at 9:00 a.m. Pursuant to the Order, if no Intervenor so notifies the Commission, the hearing shall be cancelled and this matter shall stand submitted based on the written record.

If any Intervenor wishes to appear at the hearing in opposition to the application for the proposed Cell Facility, he or she <u>must</u>, within ten (10) days of the date of this Order, so notify the Commission in writing. A copy of the notice from the Intervenor shall be mailed or delivered to all the parties of record. <u>If no statement of intent to appear at the hearing and to present evidence</u> <u>against the construction of the proposed Cell Facility is received by</u> that date, the hearing will be cancelled and the matter will be

submitted to the Commission for a decision based on the written record.¹

None of the Intervenors have advised the Commission that they intend to appear at the hearing and present evidence in opposition to the proposed Pricetown Cell Site Although the Intervenors, Terry Wilson and Mariea Jo and Carl Wilson, filed letters with the Commission on July 21, 2008 acknowledging receipt of the Order and notice of the August 27, 2008 hearing, none of the Intervenors stated that they intend to participate in the hearing.

Moreover, the Commission is not statutorily required to conduct a public hearing before granting a certificate of public convenience and necessity. KRS 278.020. "It is clear from the statutory language that the Commission may, in its discretion, choose not to hold a public hearing on an application for a Certificate of Public Convenience and Necessity, if the circumstances of the particular case do not require such a public hearing."² The circumstances of the present case do not require a public hearing. The July 9, 2008 Order expressly provides that "the hearing will be cancelled and the matter will be submitted to the Commission for a decision based on the written record" if the Intervenors do not file a written statement of intent "to appear at the hearing and to present evidence against the construction of the Commission in writing of their intent to appear at the hearing, and the time to do so has expired. Accordingly, the Commission should cancel the public hearing and take this matter under submission based on the written record.
