MOTION FOR FULL INTERVENTION

BellSouth Telecommunications, Inc., d/b/a AT&T Kentucky ("AT&T Kentucky") and AT&T Communications of the South Central States, LLC ("AT&T Communications") (collectively, "AT&T"), by counsel, hereby move the Public Service Commission of the Commonwealth of Kentucky (the "Commission"), to grant AT&T full intervention in the above-captioned matter, pursuant to 807 KAR 5:001, Section 3(8)(b).

In support of its motion, AT&T Kentucky states that it is a local and intraLATA service provider within the Commonwealth of Kentucky whose intrastate switched access rates were referenced by Verizon in its petition. AT&T Kentucky has a unique interest in assuring that any references to AT&T Kentucky and its rates are accurate. AT&T Kentucky, as an intraLATA service provider, is also subject to paying intrastate switched access charges which are the subject of this case. Any ruling, therefore, by

the Commission in this case could have a direct impact on AT&T Kentucky and its customers. As such, AT&T Kentucky has a special interest in the case not otherwise adequately represented by any other party.

In support of its motion, AT&T Communications states that it is a provider of long distance services in the Commonwealth of Kentucky and, as such, is subject to paying intrastate switched access charges which are the subject of this case. Because any ruling by the Commission in this case regarding intrastate switched access charges could have a direct impact on AT&T Communications and its customers, AT&T Communications has a special interest in the case not otherwise adequately represented by any other party.

It is appropriate, therefore, that AT&T be made parties to the case and be served with all testimony, pleadings, correspondence and all other documents submitted by parties on the undersigned counsel for AT&T.

For the foregoing reasons, AT&T respectfully requests that the Kentucky Public Service Commission grant this motion for full intervention in this case.
