O R D E R

Pursuant to the existing procedural schedule, July 11, 2008 is the due date for filing intervenor testimony in this case. The Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention ("AG"), has moved to revise the procedural schedule to allow him until July 16, 2008 to file his testimony. The AG's motion states that counsel for Blue Grass Energy Cooperative Corporation ("Blue Grass") does not object to this request.

The procedural schedule requires that data requests to intervenors be filed by July 24, 2008 with responses thereto due August 6, 2008. The schedule was recently supplemented to establish August 12, 2008 as the date for a public hearing. In order to allow sufficient time for Blue Grass and Commission Staff to review the AG's testimony and potentially prepare data requests for the AG, the dates for such data requests and responses thereto require modification.

Based on the motion and being otherwise sufficiently advised, the Commission finds the AG's request to be reasonable and will permit him to file his testimony by July 16, 2008. This change to the procedural schedule necessitates further changes, which are shown in Appendix A to this Order.

IT IS THEREFORE ORDERED that:

1. The AG's motion requesting permission to file his testimony by July 16, 2008 is granted.

2. The procedural schedule previously established is amended as set forth in Appendix A, which is attached hereto and incorporated herein.
