Dear Ms. O'Donnell,

On 02/25/2008, we sent a written request to your attention requesting an Open Records release of information pertaining to the Cherry Blossom Subdivision, Georgetown KY utility boundaries. We stated in that same letter that we would send a follow-up letter expressing our disapproval and complaint over the upcoming rate increase request from Blue Grass Energy (Case 2008.00011). We have enclosed in this package, signatures from 92% of the Cherry Blossom Subdivision residents located in the Blue Grass Energy territory as well as several supporters from the Cherry Blossom Kentucky Utilities area (total of 131 signatures), opposing this rate increase as well as conveying our denunciation of the significant current rate gap between Blue Grass Energy and other local Energy providers such as Kentucky Utilities. The signatures we received are both electronic and written. We have developed a website to collect Cherry Blossom homeowner's signatures. Attached to the signature copies, are the copy of the webpage for your reference. Please note that we feel confident we would have received more however, could not get in contact with all homeowners. We will continue to pursue until we have reached everyone.

We realize current energy prices are on the increase; however, Blue Grass Energy's costs are extremely high when compared to the state and regional averages. I have spoken to Lawrence Cook in the Attorney General's Office and shared with him our concerns. I am aware of his process as Intervener to scrutinize BGE's request in case # 2008.00011. We too would like to interpose this process to ensure our consumer right to affordability is addressed. Therefore, I am forwarding a copy to Lawrence Cook for his review. We understand that there will be a review of BGE's request for rate increase in the upcoming weeks and we hope that you will review our previous letter and current request with serious consideration.
