This letter is notice to the Commission that the three (3) above distribution cooperatives intend to file, either jointly or separately, an application for approval of retail tariff riders and revised tariffs. These distribution cooperatives are members of Big Rivers Electric Corporation and the filing(s) will be in conjunction with the wholesale tariff filings that Big Rivers has made in Case No. 2007-455 and Case No. 2007-460.


Your attention is called to the fact that included in the retail tariff riders will be an Environmental Surcharge rider for each of the three (3) distribution cooperatives.
