Recently, you commented by e-mail to the Kentucky Public Service Commission about the cooperative's recent rate filing. We receive copies of all such comments as a normal part of the rate adjustment process.

I certainly understand your concerns and comments included in your e-mail. However, I would like to have the opportunity to provide you with further information about the cooperative's need for an adjustment in rates, as well as our efforts over the years to manage costs and keep our rates as low as possible.

The effective rate per kWh you pay has gone up over the past few years, but that is solely due to the fuel adjustment and environmental costs incurred by our power supplier, East Kentucky Power. One hundred percent of the monies charged for those costs on your monthly electric bill go directly to East Kentucky Power to reimburse them for their actual costs. The Kentucky Public Service Commission regularly audits the fuel adjustment and environmental accounting processes to ensure compliance with all regulations.

Our rate request filing of January 9th, is to provide Farmers with needed monies to cover our distribution expenses. We honestly have not adjusted our electric rates for those costs since 1986.

I invite you to give me a call so we can discuss your concerns more fully. If you would prefer, I would invite you to stop by the office so we could personally visit. I work for you and all of the members and I assure you that we are trying to work in your best interest. These are tough times for everyone and I don't take that lightly. Recently, you commented by letter to the Kentucky Public Service Commission about the cooperative's recent rate filing. We receive copies of all such comments as a normal part of the rate adjustment process.

I certainly understand your concerns and comments included in your letter. However, I would like to have the opportunity to provide you with further information about the cooperative's need for an adjustment in rates, as well as our efforts over the years to manage costs and keep our rates as low as possible.

As you pointed out in your letter, the effective, bottom-line rate you pay per kWh has indeed gone up over the past few years. But the cause of that has been solely due to our power supplier's fuel and environmental costs. They are costs that are unavoidable in the generation and delivery of electricity to our members. Farmers does not retain any of the monies charged for fuel adjustment or environmental costs. One hundred percent of those dollars are forwarded to our power supplier, East Kentucky Power, to reimburse their actual costs. The Kentucky Public Service Commission regularly audits the accounting processes for the fuel adjustment and environmental surcharge to ensure that all rules and regulations have been adhered to.

Our rate request filing of January 9th, is to provide Farmers with needed monies to cover our distribution expenses. We honestly have not adjusted our electric rates for those costs since 1986.
