SUPPLEMENTAL ANSWERS OF CEDARBROOK UTILITIES, LLC, TO COMMISSION STAFF'S SECOND DATA REQUEST TO PETITIONERS

Comes the Petitioner, Cedarbrook Utilities, LLC ("Cedarbrook"), by counsel, and for its Supplement to the Answers to the Commission Staff's Second Data Request to Petitioners, states as follows:

Refer to Petitioners' Response to Item 8 of Commission Staff's First Data

Request Provide documentation to show that Cedarbrook, or its owners, currently possess the financial ability to operate R A Williams' wastewater treatment facility

ANSWER: The Asset Purchase Agreement entered into between R A Williams Construction Company, Inc ("R A Williams") and Cedarbrook provides for the payment of Twenty-two Thousand Dollars (\$22,000 00) to Cedarbrook (See Exhibit A to the Application for Transfer).

R A Williams has also agreed to pay the amount of Two Thousand Five Hundred Dollars (\$2,500 00) as its share of the legal fees incurred in preparing, filing and representing the parties in the above-styled application for transfer and to pay the amount of Five Thousand Five Hundred Dollars to Covered Bridge Utilities for the cost of managing the subject WWTP

bank account the initial amount of Fifteen Thousand Dollars (\$15,000 00) This \$15,000 00 will enable the utility to operate and to ensure the payment of its bills as they come due. Please note that in addition to this initial payment, Cedarbrook will rely upon the monthly rate authorized by the Commission to pay for the operation of the Cedarbrook WWTP, as it is incumbent upon the Commission to set a rate that will adequately fund the operation of the WWTP. The current rate for the subject WWTP is \$23.55 per month for total receipts of \$1,201.05 per month and total receipts of \$14,412 per year. Commission Staff's initial proposed rate for the subject WWTP was \$62.00 per month for total receipts of \$3,162.00 per month and total receipts of \$37,844.00 per year. Commission Staff's current proposed rate for the subject WWTP is \$46.40 per month for total receipts of \$2,366.40 per month and total receipts of \$28,396,80 per year. The initial deposit of Fifteen Thousand Dollars (\$15,000.00), exceeds the current annual receipts for the subject WWTP, is more than six times the monthly receipts of the Staff's proposed rate and more than four times the monthly receipts of the Staff's initial proposed rate, and further confirms that Cedarbrook has the requisite financial capability of operating the subject WWTP.

In addition, in order to begin making the necessary improvements to the collection system, Cedarbrook may enter into a short term loan to borrow the amount of Ten Thousand Dollars (\$10,000 00), which funds would be used to address problems with the collection system on a "worst first" basis Cedarbrook will be filing a request in the pending rate case involving the subject WWTP (Case no 2008-00042) for the Commission to include the repayment of the loan and the expenses associated with same in the new rate to be established. It is anticipated that the project to make the necessary improvements on the collection system will be carried out in a phased manner over a number of years

Finally, Cedarbrook has previously filed with the Commission its Irrevocable Letter of Credit
