APPLICATION

This Application of the U.S. 60 Water District of Shelby and Franklin Counties, Kentucky ("Applicant"), respectfully shows:

1. That Applicant is a water district of Shelby, Franklin, Spencer and Anderson Counties, Kentucky, created and existing under and by virtue of Chapter 74 of the Kentucky Revised Statutes.

2. That the post office address of Applicant is:

U.S. 60 Water District c/o Mr. Darrell Dees, Manager P.O. Box 97 Bagdad, Kentucky 40003

3. That Applicant, pursuant to the provisions of KRS 278.020 and 278.023, seeks (i) a Certificate of Public Convenience and Necessity, permitting Applicant to construct a waterworks construction project, consisting of extensions, additions, and improvements (the "Project") to the existing waterworks system of Applicant; (ii) an Order approving revised rates; and (iii) approval of the proposed plan of financing said Project.

4. That the proposed project includes the construction and installation of approximately 36,000 linear feet of 12 inch transmission main and approximately 41,000 linear feet of 6 inch distribution pipe to serve new customers in Spencer County.

5. That Applicant proposes to finance the construction of the Project through (i) the issuance of \$764,000 of its Waterworks Revenue Bonds; (ii) a USDA, Rural Development ("RD") Grant in the amount of \$272,900; (iii) a Kentucky Infrastructure Authority ("KIA") grant in the amount of \$700,065; and (iv) a contribution from Applicant in the amount of \$18,720. Applicant

has a commitment from RD to purchase said \$764,000 of bonds (in two series, consisting of \$145,000 of Series A Bonds and \$619,000 of Series B Bonds) maturing over a 40-year period, at an interest rate not exceeding 4.50% per annum as to the Series A Bonds and 4.625% per annum as to the Series B Bonds, as set out in the RD Letter of Conditions, as amended, filed herewith as an Exhibit.

6. That Applicant does not contemplate having the Project constructed with any deviation from minimum construction standards of this Public Service Commission.

7. That Applicant files herewith the following Exhibits pursuant to 807 KAR 5:069 in support of this Application:

- A. Copy of RD Letter of Conditions, as amended.
- B. Copy of RD Letter of Concurrence in Bid Award.
- C. Copy of Preliminary and Final Engineering Reports.
- D. Certified statement from the Chairman of Applicant, based upon statements of the Engineers for Applicant, concerning the following:
 - The proposed plans and specifications for the Project have been designed to meet the minimum construction and operating requirements set out in 807 KAR 5:066, Section 4(3) and (4); Section 5(1); Sections 6 and 7; Section 8(1) through (3); Section 9(1) and Section 10;
 - (2) All other state approvals or permits have already been obtained;
 - (3) The proposed rates of Applicant shall produce the total revenue requirements set out in the engineering reports; and
 - (4) Setting out the dates when it is anticipated that construction will begin and end.

8. That Applicant has arranged for the publication, prior to or at the same time this Application is filed, of a Notice of Proposed Rate Change pursuant to Section 2 of 807 KAR 5:069, in the Sentinel-News, the Spencer Magnet, and the State Journal, which are the newspapers of general circulation in Applicant's service area. Said Notice sets out the Applicant's current rates and proposed rates and a short description of the Project. A copy of said Notice is filed herewith as an Exhibit.

9. That the foregoing constitutes the documents necessary to obtain the approval of the Public Service Commission in accordance with Section 278.023 of the Kentucky Revised Statutes and in accordance with the Filing Requirements specified in 807 KAR 5:069, Section 1.

WHEREFORE, Applicant, U.S. 60 Water District of Shelby and Franklin Counties, Kentucky, asks that the Public Service Commission of the Commonwealth of Kentucky grant to Applicant the following:

- a. A Certificate of Public Convenience and Necessity permitting Applicant to construct a waterworks project consisting of extensions, additions, and improvements to the existing waterworks system of Applicant.
- b. An Order approving the financing arrangements made by Applicant, viz., the issuance of (i) \$764,000 of U.S. 60 Water District Waterworks Revenue Bonds at an interest rate of not exceeding 4.50% per annum as to the Series A Bonds and 4.625% per annum as to the Series B Bonds; (ii) an RD Grant in the amount of \$272,900; (iii) a KIA grant in the amount of \$700,065; and (iv) an Applicant contribution in the amount of \$18,720.
- c. An Order approving the proposed increased rates as set out in Section 25 of the Amended RD Letter of Conditions filed herewith as an Exhibit.

Dear Mr. Eggen:

This letter establishes conditions which must be understood and agreed to by you before further consideration may be given to the application. The loan and/or grant will be administered on behalf of the Rural Utilities Service (RUS) by the State and Area office staff of USDA Rural Development. Any changes in project cost, source of funds, scope of services or any other significant changes in the project or applicant must be reported to and approved by USDA Rural Development, by written amendment to this letter. Any changes not approved by Rural Development shall be cause for discontinuing processing of the application. It should also be understood that Rural Development is under no obligation to provide additional funds to meet an overrun in construction costs.

This letter is not to be considered as loan and/or grant approval or as a representation as to the availability of funds. The docket may be completed on the basis of a RUS loan not to exceed \$764,000, a RUS grant not to exceed \$272,900, and a Kentucky Infrastructure Authority (KIA) 2020 grant of \$744,000. The RUS loan will be separated into two Bond Issues (Series A and Series B). The Series A will be \$145,000 at poverty interest rate, and the Series B will be \$619,000 at market interest rate.

If Rural Development makes the loan, the interest rate will be the lower of the rate in effect at the time of loan approval or the rate in effect at the time of loan closing, unless the applicant otherwise chooses. The loan will be considered approved on the date a signed copy of Form RD 1940-1, "Request for Obligation of Funds," is mailed to you.

Please complete and return the attached Form RD 1942-46, "Letter of Intent to Meet Conditions," if you desire that further consideration be given to your application.

The "Letter of Intent to Meet Conditions" must be executed within three weeks from the date of this letter or it becomes invalid unless a time extension is granted by Rural Development.

If the conditions set forth in this letter are not met within 240 days from the date hereof, Rural Development reserves the right to discontinue the processing of the application.

In signing Form RD 1942-46, "Letter of Intent to Meet Conditions," you are agreeing to complete the following as expeditiously as possible:

1. Number of Users and Their Contribution:

There shall be 2,027 water users, of which 1,957 are existing users and 70 are new users contributing \$36,100 in connection fees toward the cost of the project. The connection fees will be collected prior to advertising for construction bids and will be placed in the construction account at loan pre-closing, unless spent for authorized purposes prior to loan pre-closing. The Rural Development Manager will review and authenticate the number of users and amount of connection fees <u>prior to advertising for construction bids</u>. No contribution is required from the Water District.

1a. Grant Agreement:

Attached is a copy of RUS Bulletin 1780-12, "Water and Waste System Grant Agreement," for your review. You will be required to execute a completed form at the time of grant closing.

1b. Drug-Free Work Place:

Prior to grant approval, the Water District will be required to execute Form AD-1049, "Certification Regarding Drug-Free Workplace Requirements (Grants) Alternative I - For Grantees Other Than Individuals."

2. <u>Repayment Period</u>:

The loan will be scheduled for repayment over a period not to exceed 40 years from the date of the bond. Principal payment will not be deferred for a period in excess of two years from the date of the bond. Payments will be in accordance with applicable KRS, which requires interest to be paid semi-annually (February 1st and August 1st) and principal will be due on or before the first of February. Rural Development may require the Water District to adopt a supplemental payment agreement providing for monthly payments of principal and interest so long as the bond is held or insured by RUS. Monthly payments will be approximate amortized installments.

3. <u>Recommended Repayment Method:</u>

Payments on this loan can be made using the Preauthorized Debit (PAD) payment method. This procedure eliminates the need for paper checks and ensures timely receipt of RD loan payments. To initiate PAD payments, Form SF 5510, "Authorization Agreement for Preauthorized Payments," should be signed by the District to authorize the electronic withdrawal of funds from your designated bank account on the exact installment payment due date. The Rural Development Manager will furnish the necessary forms and further guidance on the PAD procedure.

4. Funded Depreciation Reserve Account:

The Water District will be required to deposit \$370.00 per month into a "Funded Depreciation Reserve Account" until the account reaches \$44,400. The deposits are to be resumed any time the account falls below the \$44,400.

The required monthly deposits to the Reserve Account and required Reserve Account levels are in addition to the requirements of the Water District's prior bond resolutions.

The monthly deposits to the Reserve Account are required to commence with the first month of the first full fiscal year after the facility becomes operational.

5. <u>Security Requirements</u>:

A combined pledge of gross water revenue will be provided in the Bond Resolution. Bonds shall rank on a parity with existing bonds, if possible. If this is not possible, the bond will be subordinate and junior to the existing bonds, in which case the Water District will be required to abrogate its right to issue additional bonds ranking on a parity with the existing bonds, so long as any unpaid indebtedness remains on this bond issue.

6. Land Rights and Real Property:

The Water District will be required to furnish satisfactory title, easements, etc., necessary to install, maintain and operate the facility to serve the intended users. <u>The pipelines will be on private rights-of-way where feasible</u>. Easements and options are to be secured prior to advertising for construction bids.

7. <u>Organization</u>:

The Water District will be legally organized under applicable KRS which will permit them to perform this service, borrow and repay money.

8. Business Operations:

The Water District will be required to operate the system under a well-established set of resolutions, rules and regulations. A budget must be established annually and adopted by the Water District after review by Rural Development. At no later than loan pre-closing, the Water District will be required to furnish a prior approved management plan to include, as a minimum, provisions for management, maintenance, meter reading, miscellaneous services, billing, collecting, bookkeeping, making and delivering required reports and audits.

9. Accounts, Records and Audits:

The Water District will be required to maintain adequate records and accounts and submit annual budgets and year-end reports (annual audits) in accordance with subsection 1780.47 of RUS Instruction 1780 and RUS Staff Instruction 1780-4, a copy of which is enclosed.

10. Accomplish Audits for Years in Which Federal Financial Assistance is Received:

The Water District will accomplish audits in accordance with OMB Circular A-133, during the years in which federal funds are received. The Water District will provide copies of the audits to the Area Office and the appropriate Federal cognizant agency as designated by OMB Circular A-133.

11. Insurance and Bonding:

The following insurance and bonding will be required:

- A. Adequate Liability and Property Damage Insurance including vehicular coverage, if applicable, must be obtained and maintained by the Water District. The Water District should obtain amounts of coverage as recommended by its attorney, consulting engineer and/or insurance provider.
- B. Worker's Compensation The Water District will carry worker's compensation insurance for employees in accordance with applicable state laws.
- C. Fidelity Bond The Water District will provide Fidelity Bond Coverage for all persons who have access to funds. Coverage may be provided either for all individual positions or persons, or through "blanket" coverage providing protection for all appropriate employees and/or officials. The amount of coverage required for all RUS loans is \$90,000.
- D. Real Property Insurance The Water District will obtain and maintain adequate fire and extended coverage on all structures including major items of equipment or machinery located in the structures. The amounts of coverage should be based on recommendations obtained by the Water District from its attorney, consulting engineer and/or insurance provider. Subsurface lift stations do not have to be covered except for the value of electrical and pumping equipment therein.
- E. Flood Insurance The Water District will obtain and maintain adequate coverage on any facilities located in a special flood and mudslide prone areas.

12. Planning and Performing Development:

- A. The engineer should not be authorized to commence work on final plans and specifications until a determination has been made that the project can be planned and constructed within the estimated cost shown in paragraph "22" of this letter. The engineer may then proceed to develop final plans and specifications to be completed no later than 210 days from this date, and prepare bid documents. The Rural Development Manager is prepared to furnish the necessary guide for him to follow so as to keep the project plans and documents within our guidelines and requirements. The project should not be advertised for construction bids until all easements and enforceable options have been obtained, and total funds are committed or available for the project.
- B. The following documents will be submitted to Rural Development for review and must be concurred in by Rural Development prior to advertisement for construction bids:
 - 1. Final plans, specifications and bid documents.
 - 2. Applicant's letter on efforts to encourage small business and minorityowned business participation.
 - 3. Legal Service Agreements.
 - 4. Engineering Agreements.

1:

Prior to receipt of an authorization to advertise for construction bids, the Water District will obtain advance clearance from Bond Counsel regarding compliance with KRS 424 pertaining to publishing of the advertisement for construction bids in local newspapers and the period of time the notice is required to be published.

13. Compliance with Section 504 of the Rehabilitation Act of 1973:

The Water District will be required to comply with Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C. 794), in order to make sure no handicapped individual, solely by reason of their handicap, is excluded from participation in the use of the water system, be denied the benefits of the water system, or be subjected to discrimination.

14. <u>Closing Instructions</u>:

The Office of General Counsel, our Regional Attorney, will be required to write closing instructions in connection with this loan. Conditions listed therein must be met by the Water District.

15. Compliance with Special Laws and Regulations:

The Water District will be required to conform with any and all state and local laws and regulations affecting this type project.

16. <u>System Operator</u>:

The Water District is reminded that the system operator must have an Operator's Certificate issued by the State.

- 17. Prior to Pre-Closing the Loan, the Water District will be Required to Adopt:
 - A. Form RUS Bulletin 1780-27, "Loan Resolution (Public Bodies)."
 - B. Form RD 400-1, "Equal Opportunity Agreement."
 - C. Form RD 400-4, "Assurance Agreement."
 - D. Form AD-1047, "Certification Regarding Debarment, Suspension, and Other Responsibility Matters - Primary Covered Transaction."
 - E. Form RD 1910-11, "Applicant Certification Federal Collection Policies for Consumer or Commercial Debts."
 - F. RD Instruction 1940-Q, Exhibit A-1, "Certification for Contracts, Grants and Loans."

The Water District must offer the opportunity for all residents in the service area to become users of the facilities regardless of race, creed, color, religion, sex, national origin, marital status, physical or mental handicap or level of income.

18. Refinancing and Graduation Requirements:

The Water District is reminded that if at any time it shall appear to the Government that the Water District is able to refinance the amount of the RUS indebtedness then outstanding, in whole or in part, by obtaining a loan from commercial sources at reasonable rates and terms, upon the request of the Government, the Water District will apply for and accept such loan in sufficient amount to repay the Government.

19. Commercial Interim Financing:

The Water District will be required to use commercial interim financing for the project during construction for the RUS loan portion of the financing, if available at reasonable rates and terms.

Before the loan is closed, the Water District will be required to provide Rural Development with statements from the contractor, engineer and attorneys that they have been paid to date in accordance with their contract or other agreements and, in the case of the contractor, that he has paid his suppliers and sub-contractors.

20. Disbursement of Project Funds:

A construction account for the purpose of disbursement of project funds (RUS) will be established by the Water District prior to start of construction. The position of officials entrusted with the receipt and disbursement of RUS project funds will be covered by a "Fidelity Bond," with USDA Rural Development as Co-Obligee, in the amount of construction funds on hand at any one time during the construction phase.

During construction, the Water District shall disburse project funds in a manner consistent with subsection 1780.76 (e) of RUS Instruction 1780. Form RD 1924-18, "Partial Payment Estimate," or similar form approved by Rural Development, shall be used for the purpose of documenting periodic construction estimates, and shall be submitted to Rural Development for review and acceptance. Prior to disbursement of funds by the Water District, the Board of Directors shall review and approve <u>each</u> payment estimate. <u>All bills and vouchers must be approved by Rural Development prior</u> to payment by the Water District.

Form RD 440-11, "Estimate of Funds Needed for 30-Day Period Commencing _____," will be prepared by the Water District and submitted to Rural Development in order that a periodic advance of federal cash may be requested.

Monthly audits of the Water District's construction account records shall be made by Rural Development.

21. Disbursement of Grant Funds:

The RUS funds will be advanced as they are needed in the amount(s) necessary to cover the RUS proportionate share of obligations due and payable by the Water District. Grant funds, upon receipt, must be deposited in an interest bearing account in accordance with 7 CFR part 3016 (as applicable). Interest earned on grant funds in excess of \$100 (as applicable) per year will be submitted to RUS at least quarterly.

23. <u>Debt Collection Improvement Act (DCIA) of 1996</u>:

The Debt Collection Improvement Act (DCIA) of 1996 requires that <u>all</u> federal payments after January 1, 1999, must be made by Electronic Funds Transfer/Automated Clearing House (EFT/ACH). Borrowers receiving payments by EFT will have funds directly deposited to a specified account at a financial institution with funds being available to the recipient on the date of payment. The borrower should complete Form SF-3881, "Electronic Funds Transfer Payment Enrollment Form," for each account where funds will be electronically received. The completed form(s) must be received by Rural Development at least thirty (30) days prior to the first advance of funds.

24. Use of Remaining Project Funds:

The applicant contribution shall be considered as the first funds expended. After providing for all authorized costs, any remaining project funds will be considered to be RUS/KIA 2020 grant funds and refunded in proportion to participation in the project. If the amount of unused grant funds exceeds the grants, that part would be RUS loan funds.

25. <u>Rates and Charges</u>:

Rates and charges for facilities and services rendered by the Water District must be at least adequate to meet cost of maintaining, repairing and operating the water system and meeting required principal and interest payments and the required deposits to debt service and/or depreciation reserve.

26. Water Purchase Contract:

The Water District will submit a Water Purchase Contract for approval by Rural Development before advertising for construction bids. If the contract is not on Form RD 442-30, "Water Purchase Contract," the contract will require approval by our Regional Attorney. The contract must meet the requirements of subsection 1780.62 of RUS Instruction 1780.

27. Commitment of KIA 2020 Grant:

This Letter of Conditions is issued contingent upon a firm commitment being in effect prior to advertising for construction bids for the KIA 2020 grant in the amount of \$744,000.

28. Floodplain Construction:

The Water District will be required to pass and adopt a Resolution or amend its By-Laws whereby the Water District will deny any water service to any future customer wishing to build on or develop property located within a designated floodplain. If a customer or developer requests service for construction in a designated floodplain, the customer or developer must provide evidence and a justification for approval by the Water District and Rural Development officials that there are no other alternatives to construction or development within the designated floodplain. The community must be a participant in the National Flood Insurance Program (NFIP) and the customer or developer must obtain the required permits prior to the tap on restrictions being waived.

29. Mitigation Measures:

- A. The project shall be in compliance with all requirements noted in the Kentucky Department for Local Government letter dated May 30, 2002, from Mr. Ronald A. Cook, Manager.

- D. The design and construction shall be in compliance with all local, state and federal environmental statutes, regulations and executive orders applicable to the project.

Final approval of this loan will depend on your willingness, with the assistance of all your co-workers, to meet the conditions of this letter in an orderly and systematic manner. Then too, final approval will depend on funds being available.

In addition, the District is extending approximately 41,048 linear feet of 6-inch PVC distribution pipe into the un-served portion of Spencer County. The Spencer County extension will initially serve 30 new customers, growing to more that 70 new customers in the immediate future.

The low bidding contractor for the project is Southern Backhoe, Inc, 808 Main Street, Campbellsville, Kentucky with a winning bid \$1,423,136.95 for the 12-inch line. The method of financing the project is a combination of Kentucky Infrastructure Authority (KIA)and Rural Development (RD) grants and a loan from the Rural Development. KIA has awarded two grants of \$650,000 and \$50,065 for the project. RD has awarded a grant of \$272,900 and is providing a loan in the amount of \$764,000. PRELIMINARY ENGINEERING REPORT

for

TRANSMISSION LINES & SYSTEM IMPROVEMENTS of U. S. 60 WATER DISTRICT

1. INTRODUCTION

The purpose of this report is to present engineering information and economic feasibility for improvements to the public water supply system of the U. S. 60 Water District of Shelby and Franklin County, Kentucky. The firm of Warner A. Broughman III & Associates was retained by the District to investigate their existing water distribution system and to make specific recommendations for improvements.

Primary consideration was given to increasing the flow of water from the supplier to the system. The secondary consideration is the extension of distribution lines into Spencer County. Numerous field and office studies were made to determine the desirability and feasibility of various alternatives. This report presents the conclusions and recommendations of the Engineer.

2. SERVICE AREA

The U. S. 60 Water District provides potable water to approximately 1,850 customers in an area roughly following U. S. 60 and Kentucky Highway 395 in southeastern Shelby County and southwestern Franklin County (see Figure 1), and a small portion of Anderson County and northeast Spencer County. The service area includes the communities of Clay Village, Peytona, Waddy, Harrisonville, and Graefenburg in Shelby County, and a portion of Bridgeport in Franklin County. More specifically, the area is defined by Shelby, Franklin, Anderson and Spencer County Court Orders as seen in Figure 1 "District Boundary" following this section.

The Water District's service area is bounded on the north by the North Shelby Water Company, on the west by the City of Shelbyville, on the south by the City of Taylorsville, and Taylorsville Lake and on the east by the City of Frankfort, Farmdale Water District and Alton Water District.

The terrain itself is gently rolling to rolling topography with occasional hills or knobs and steeper areas near the larger streams. Elevations range from a low of approximately 680 feet above mean sea level at Benson Creek in Bridgeport, to some 1,188 feet above mean sea level on Jeptha Knob near Clay Village.

The major underlying rock formations consist chiefly of limestone with considerable interbedding of shale. Most of the soils have a moderate to high fertility. Not surprisingly, the major land use in the District is for agriculture while rural residential tracts are the second largest. Ground water availability is generally poor in the U. S. 60 Water District. Few wells drilled in the shale or shaly limestone formations yield enough water for domestic use. Expected yield for a well in this part of Kentucky is less than 5 gallons per minute. There are several springs in this area, but most go dry in late summer.

Because of the agricultural need for water, the area is dotted with numerous man-made farm ponds. These, of course, draw down considerably during the summer months. Benson Creek, a tributary of the Kentucky River, and Guist Creek Lake, and Taylorsville Lake are the major bodies of surface water in the District.

3. EXISTING FACILITIES

3.1 PHYSICAL PLANT

Following this section is Figure 2: U. S. 60 Water District map that provides a graphic representation of the physical plant.

3.1.1 SOURCES

The U. S. 60 Water District purchases finished water from the City of Frankfort, Kentucky, whose source is the Kentucky River. The U. S. 60 system does not contain any treatment facilities. The physical plant consists of a distribution system made up of some 35 miles of pipeline, four water storage tanks, and two water pumping stations (See Figure 2). The majority of the distribution system was constructed in 1965 when the District first began operation. In the

All that land in Franklin County, Kentucky lying within the following described boundary:

BEGINNING at a point in the center of U.S. Highway 60 in the center of South Benson Creek; thence northwesterly to the intersection with Ky. Highway 1665 with the mean sea level elevation contour line of 750 feet, thence with said 750 feet contour line in a northerly direction generally along the east side of said Ky. 1665 to a point, said point being 1100 feet east of the centerline of Ky. 1665 and 1300 feet south of the centerline of Pea Ridge Road; thence north 800 feet to a point in the west property line of Dorthy Kirk, thence with said property line to the center of Pea Ridge Road, thence north to the center of Pea Ridge Road, thence north to the center of Benson Creek; thence west along the center of Benson Creek and North Benson Creek to the Franklin-Shelby County line; thence south along said county line to a point one mile south of U.S. Highway 60; thence in an easterly direction one mile south of U.S. Highway 60 to a point one mile south of the intersection of U.S. Highway 60 and South Benson Creek; thence north to the beginning point.

BEGINNING at a point in the centerline of U.S. Highway 60, said point being 3000 feet east of the centerline of Guist Creek; thence due north approximately 1000 feet to the centerline of the main stem of Guist Creek Lake; thence in a northeasterly direction along said centerline of the main stem of Guist Creek Lake (Tick Creek) to a point which is one mile north of U.S. Highway 60; thence in an easterly direction one mile north of and parallel to U.S. Highway 60 to the Shelby-Franklin County line thence with the Shelby County line in a southerly direction to the intersection of the Shelby, Anderson and Spencer County lines; thence in a northwesterly direction with the Shelby-Spencer County line to the centerline of Guist Creek; thence in a northerly direction with the centerline of Guist Creek to the centerline of Hoopers Station Road; thence due north to the southern right-of-way of I-64; thence in an easterly direction with the southern rightof-way of I-64 to a point 1000 feet west of the intersection of I-64 and Hoopers Station Road; thence crossing I-64 in a northeasterly direction 1000 feet northwest of and parallel to the centerline of Hoopers Station Road to a point, said point being on a line, said line beginning at a point 6.5 miles due west of the intersection of the Shelby-Anderson County line and Kentucky Highway 637 (now Kings Highway) and terminating at a point in the centerline of U.S. Highway 60 3000 feet east of the centerline of Guist Creek; thence along said line in a northerly direction to the point of beginning.


All that land in Spencer County, Kentucky, lying within the following described boundary:

BEGINNING at a point in the Spencer County boundary with Shelby and Anderson Counties: thence south along the Anderson County line to the Nelson County line; thence southwest approximately one mile along the Nelson County line to a point in the center of Taylorsville Lake; thence with the centerline of said lake to Beech Creek; thence northeast along Beech Creek to the head of Ten Mile Creek said point being one-half mile southwest of the Spencer and Shelby County line; thence one-half mile northeast to the Spencer and Shelby County line; thence southeast along said county line approximately 4.5 miles to the point of beginning.

All that land in Anderson County, Kentucky, lying within the following described boundary:

BEGINNING at a point in the Anderson County line, common with Shelby and Franklin Counties, thence along the Anderson and Franklin County line to Benson Creek; thence south along Benson Creek to a point 1000 feet northeast of the Benson Road bridge; thence south with a line running 1000 feet from and parallel to Kentucky Highway 50 to a point on that line due southeast of the intersection of Kentucky 50 and Tracy Road; thence southwest approximately 6 miles to a point, said point being 1000 feet south of Pleasant Hill church; thence northwest 1000 feet south of the Pleasant Hill Church; thence northwest 1000 feet south of the Pleasant Hill Church; thence northwest 1000 feet from and parallel to Kentucky Highways 44/53 to a point in the Anderson-Spencer County line; thence northeast with the Anderson-Spencer County line to the Shelby County line; thence northeast with the Shelby-Anderson County line to the point of beginning.

connection to the City of Frankfort's system at Bridgeport and constructed westerly 2.0-miles along U.S. Highway 60. The trunk was increased to 6" diameter and continued 5.5-miles along U. S. Highway 60 to Peytona. At Peytona the water line continues 2.6-miles along U. S. Highway 60 to Keys Road at Guist Creek Lake. At the same time a 4" diameter pipeline was constructed 3.0miles

along Kentucky Highway 395 from Peytona to Waddy. In addition, some 2.0-miles of 4" and smaller lateral distribution mains were also installed. The 1965 improvements utilized Asbestos Cement pipe. Between the Districts original 1965 construction and 1978, some 2.5-miles of additional pipelines were constructed. Because of elevation extreme, a small pump and pressure tank serves the Jeptha Knob Road.

The District made large extension and renovations in 1978, 1984, and 1998 constructing a new tank to replace the inadequate tank at Waddy, renovation of the pump station and constructing new pipelines. The new pipelines extend the distribution system west along U. S. 60 to KY 714, south along KY 714 and KY 1790 and south along Wentworth Road (Buzzard Roost). A larger line was constructed to connect to the supply at Bridgeport. These pipelines were constructed using PVC pipes.

The District made several extensions in 1992 adding new pipeline along Catridge Road in Shelby County; Benson and Avenstoke Roads in Anderson County; and Sheepen, Taylor Branch and Botkin Roads and Kentucky Hwy 1665 in Franklin County. The 1998 project added a new elevated water storage tank and 15-miles of pipelines in Spencer County along Smitha road, Murphy Lane, KY 636 and KY 248.

All of the U.S. 60 water is bought wholesale from the Frankfort Electric and Water Board. All of the water that is purchased is already treated and the District does not have its own treatment facilities. The District sold more than 142 million gallons of water in 2001. The following Table 1 breaks down sales and purchases of water.

4. EXISTING FINANCIAL STATUS

4.1 REVENUE

The total 2001 revenue for the District was approximately \$654,490 resulting from the sale of approximately 115,032,100 gallons of water. For 2001 the District had a net income of \$52,361.

The 1986, 1992, and 1998 bonds are unsettled revenue bond issues with the Rural Development agency of the U.S. Department of Agriculture (formerly Farmers Home Administration). The two notes are with the Kentucky Infrastructure Authority. The two fixed-rate leases are with the Kentucky Association of Counties through the Shelby County Fiscal Court. All payments occur annually except for the two leases that occur monthly.

The 1986 bond issue of \$350,000 at 7.625% interest has a remaining balance of \$300,000. The 1992 bond issue of \$262,000 at 6.125% interest has a balance of \$278,400. The 1998 bond issue of \$460,700 at 4.5% interest has a balance of \$428,500. The District has two notes with the

Kentucky Infrastructure Authority. The first note is for \$227,564 at 6.9% and has a balance of \$60,000. The second note is for \$510,857 and has a remaining balance of \$240,000. The KaCO Leasing Trust holds a fixed rate lease for \$237,000 at 4.539% interest with a remaining balance of \$110,000. A second lease of \$82,000 at 5.524% interest has a remaining balance of \$52,000.

5. PROPOSED FACILITIES AND SERVICES

The U.S. 60 Water District has been supplying potable water to its customers since 1966. These thirty-six years of operation have produced increased demands on the system.

The District proposes to extend a new transmission main from Bridgeport in Franklin County to Graefenburg in Shelby County. The water line will extend along U.S. Highway 60. The extension will serve no new customers along the route. A hydraulic analysis was conducted on the water distribution system, as it would exist with the proposed transmission main. The calculations were based upon an average flow of 0.6-gpm for each customer and 5-gpm for dead end lines.

New distribution mains are proposed for several unserved areas of Spencer County. Ten Mile, Sego, Cull and Stoney Hollow Roads along with Cook and Mitchell Lanes are all unserved roads in Spencer County. The water mains will be extended along these roads.

5.1 STORAGE

The Water District currently has four storage facilities with a total capacity of 535,000 gallons. Of this amount approximately 367,500 gallons can be considered available storage. The average daily sale was 315,156 gallons in 2001.

5.2 SOURCE

The current source of water for the U.S. 60 Water District is water purchased from the City of Frankfort. The Frankfort Plant Board has a modern treatment plant rated at 18 million gallons per day. The Plant Board's 2001 production averaged about 8.153-mgd. The Plant Board currently charges the U.S. 60 Water District a wholesale price of \$1.539 per 1,000 gallons. Alternate sources include buying water from the City of Shelbyville or constructing a water treatment plant. The region within the boundaries of the Water District contains only two large bodies of surface water: 1) Guist Lake, which is the impoundment source for the City of Shelbyville; and 2) Taylorsville Lake. In addition, there are relatively limited quantities of groundwater. The construction of a treatment plant, would make producing water quite expensive.

5.3 DISTRIBUTION SYSTEM

The proposed transmission main will allow the District to bring in sufficient water to service its existing customers' property and reduce operating time on pumps and personnel. The existing 4-inch and 6-inch pipelines can no longer provide water in a timely fashion. The 12-inch pipeline will allow 1,000 to 1,500 gpm of water from the supplier to enter the U.S. 60 distribution system.

The planned distribution lines into Spencer County consist of 6-inch and 8-inch PVC lines along the rural areas. The line will be fed from the existing system of 8-inch mains and elevated storage tank.

5.4 PRESSURE

During average conditions, the existing distribution system maintains static pressures from about 35 psi to over 100 psi in the lower part of the system. During withdrawals, of course, the system's dynamic pressures are somewhat less. Under normal operating condition such pressure drops are barely noticeable to the majority of the District's customers. The proposed changes (i.e. new water storage tank, line upgrade, and pump upgrade) will not appreciably affect the system's static pressure. But, they are expected, however, to improve residual pressures during peak demands.

6. COST ESTIMATES

An itemized estimate of the cost of the project outlined in the previous discussion is given below in Table 3 - Project Cost. These costs are approximate only and are based on available information on the costs of similar 2006 projects. ł.

7. ANNUAL OPERATING BUDGET

7.1 INCOME

The existing rate schedule for the U.S. 60 Water District is shown in Table 3. It was pointed out earlier in this report that the District generated \$808,616 with their current rate schedule in 2006. Interest, dividend and non-operating income added \$32,475 to the total revenues for 2006. After expenses, this gave net income of \$41,736.

7.2 OPERATION & MAINTENANCE COSTS

The 2006 year end records reflect various expenses for operation and maintenance of the system. Evaluation of those expenses along with the addition of 30 new customers from normal growth suggests that the following expenditures will occur in the first year after construction.

7.3 DEBT REPAYMENTS

The current debt of the District is \$1,056,300 in Rural Development bonds, \$632,477 in Kentucky Infrastructure Authority Notes and leases with the Kentucky Association of Counties Leasing Trust for \$240,000. The yearly debt service amounts to \$154,780 for the four types of debt.

The total projected expenses for the District are \$707,401 in operating and debt service plus \$181,093 in depreciation for total of \$888,494. The expected revenue from existing customers is \$864,000.

The new project will add \$40,068 in debt service, including 20% bond coverage, and \$45,423 in additional depreciation, for a total projected expense of \$85,491. The new debt service results in a revenue shortfall of \$109,985.

8. CONCLUSIONS AND RECOMMENDATIONS

The Kentucky Infrastructure Authority has awarded the District a \$650,000 grant for the transmission line and tank and a \$50,065 grant for distribution lines in Spencer County to complete the project outlined herein. The transmission main is necessary in order to add any new customers in Spencer or other counties. The distribution lines are to serve water to unserved areas in low income rural areas of Spencer County.

It is recommended that the District apply for a loan and grant package through Rural Development. The loan is recommended to be \$912,500 and the grant is expected to be \$500,000.

The total number of customers on the district as of September 1, 2007 is 2,246, including eight churches, two truck stops and two schools. The total number of existing Spencer County residential customers is 188 and the number of new Spencer County residential customers is 30.

The additional debt service will necessitate a rate increase of approximately 14%. The rate schedule in Table 10 shows the proposed rates. It is recommended that the District petition the PSC to audit our accounts and recommend a new water rate.
