MOTION OF NORTHERN KENTUCKY COMMUNITY ACTION COMMISSION TO INTERVENE

Pursuant to 807 KAR 5:001, Sec. 3(8) the Northern Kentucky Community Action Commission, Inc. ("NKCAC") moves the Commission for an Order granting permission and leave for NKCAC to fully intervene as a party to this proceeding.

In support of this Motion, NKCAC states as follows:

- 1. NKCAC is a statutorily authorized community services commission that provides services to economically disadvantaged persons in an eight county Northern Kentucky region. *KRS* 273.405–453. NKCAC, whose Executive Director is Ms. Florence Tandy, has a business address at 717 Madison Ave, P.O. Box 931, Covington, KY 41011.
- 2. NKCAC will be represented in this proceeding by its outside counsel, Thomas Vergamini, Taft Stettinius & Hollister LLP, 1717 Dixie Highway, Suite 340, Covington, Kentucky 41011-4704. Mr. Vergamini is authorized to practice law in the Commonwealth of Kentucky.
- 3. NKCAC is a member of the Residential Collaborative that participates with Duke Energy Kentucky ("DE-Kentucky") and other interested parties in approved Demand Side Management energy programs that DE-Kentucky has available.
- 4. The subject matter of this specific proceeding affects NKCAC and its clients.

Therefore, the full intervention of NKCAC as a party to this proceeding is required to assure

that the interests of the clients of NKCAC are met and protected.

5. The intervention of NKCAC in this proceeding will not unreasonably delay this

proceeding and will allow the Commission to better evaluate the filing made by DE-

Kentucky.

6. This proceeding was initially part of a separate Application involving a DE-

Kentucky Demand Services Management program (Case No. 2007-00369) that is pending

before the Commission. In that prior Application NKCAC was identified as an interested

party as shown in the certificate of services statements accompanying the pleadings filed in

that proceeding.

7. NKCAC submits that good cause exists for the Commission to approve and

grant this Motion to Intervene.

WHEREFORE, NKCAC respectfully requests that the Commission approve this

Motion and issue an Order granting NKCAC the right to fully intervene as party in this

proceeding.
