O R D E R

The Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention ("AG"), has moved the Commission to modify the procedural schedule to permit the AG to issue additional data requests to the parties and to file amended comments concerning Duke Energy Kentucky, Inc.'s ("Duke") proposed Home Energy Assistance Program. In support of his motion, the AG asserts that further information is needed to clarify the scope of the program. The AG filed his supplemental requests for information contemporaneous with the filing of the motion.

The Commission, having reviewed the motion and being otherwise sufficiently advised, finds that the AG has shown good cause to amend the procedural schedule established by the Commission on April 16, 2008.

IT IS THEREFORE ORDERED that:

1. The AG's motion to modify the procedural schedule is granted.
2. The AG's supplemental requests for information to Duke and to Northern Kentucky Community Action Commission ("NKCAC") are hereby deemed filed and made a part of the official record in this case.
