

ORDER

On May 5, 2008, Richard G. Beach, an attorney licensed to practice law in the Commonwealth of Kentucky who is representing Duke Energy Kentucky, Inc. ("Duke Kentucky"), moved the Commission to admit *pro hac vice* Rocco O. D'Ascenzo, regulatory counsel for Duke Energy Shared Services, Inc., a subsidiary of Duke Energy Corporation, to practice law before the Commission and to appear on behalf of Duke Kentucky. In support of the request, Mr. D'Ascenzo has shown that he is a member in good standing of another state bar and has been certified to practice before the Commission in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2). Beach, or another member of the Kentucky Bar Association, acts as co-counsel and is present at any and all proceedings before this Commission.
