On April 16, 2008, BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky") provided written notice to the Commission of its intent to disconnect State Discount/Bellerud Communications, LLC ("State Discount") for non-payment of bills. AT&T Kentucky requested authorization to invoke the Emergency Service Continuity Tariff approved by this Commission on May 20, 2003 in Case No. 2002-00310.<sup>1</sup>

On April 18, 2008, AT&T Kentucky notified the Commission that it was withdrawing the request due to receipt of State Discount's payment.

The Commission, having reviewed AT&T Kentucky's notice and subsequent filing, and having been otherwise sufficiently advised, HEREBY ORDERS that:

1. AT&T Kentucky's request to withdraw this matter is granted.
2. Copies of AT&T Kentucky's notice of intent to disconnect State Discount and withdrawal of same are attached hereto and incorporated herein.







Dear Ms. Stumbo:

AT&T is providing advance notice to the Kentucky Public Service Commission (PSC) of AT&T's intent to disconnect State Discount/Bellerud Communications, LLC for non-payment.<sup>1</sup> AT&T's records indicate that State Discount/Bellerud Communications, LLC is delinquent in payment of its bills to AT&T.

Attempts to collect past due amounts from State Discount/Bellerud Communications, LLC have been unsuccessful. AT&T made numerous written notifications to State Discount/Bellerud Communications, LLC informing them of AT&T's intent to suspend or terminate services consistent with the terms and conditions of the Interconnection Agreement between State Discount/Bellerud Communications, LLC and AT&T. As of today, AT&T has received no payment from State Discount/Bellerud Communications, LLC and we seek to begin discontinuance of services immediately. Disconnection of State Discount/Bellerud Communications, LLC services will affect less than 10 Kentucky customers. Under terms of their Resale Agreement, State Discount/Bellerud Communications, LLC is solely responsible for notifying its end users of the proposed service disconnection. AT&T is copying State Discount/Bellerud Communications, LLC to remind them of their obligations to notify their end users of this situation regarding pending disconnection of services.

Should the Commission determine the need to invoke AT&T's Emergency Service Continuity Tariff, AT&T will take steps to notify the affected end users and inform them that they may continue to receive telecommunications services through The Emergency Services Continuity Plan for a minimum of fourteen (14) days and that the end user must transition to a new service provider.
