Dear Mr. Derouen:

In its January 8, 2009, Order in the above-referenced matter, the Kentucky Public Service Commission ordered all jurisdictional utilities to file net metering tariffs and application forms to comply with the "Interconnection and Net Metering Guidelines - Kentucky" on or before April 8, 2009. Big Rivers Electric Corporation ("Big Rivers") is a wholesale generation and transmission cooperative that has no retail customers. Any retail customers on the Big Rivers system wishing to participate in net metering would have to do so through one of Big Rivers' three distribution cooperative members ("Members") who provide retail electric service. Each of Big Rivers' Members have filed or will file net metering tariffs to comply with the "Interconnection and Net Metering Guidelines - Kentucky." Net metering will thus be available to all qualifying retail customers on the Big Rivers system, and Big Rivers will not be filing a net metering tariff.
