The City of Danville ("the City") hereby requests an extension of the schedule for briefing and for responding to hearing data requests set during the 3/10/09 Hearing. As suggested by the Hearing Officer (*see* Transcript pgs. 199-200), the parties met that day to discuss agreeing on a resolution, rather than the Commission having to take action. The parties have made progress, and continue to work toward a resolution of their disputes, including over the 2005-2007 purchase power adjustments to rates that affected billings from mid-2005 through mid-2008. However, at this point, an extension is necessary for the parties to further discuss settlement of their various disputes, to clarify rates going-forward and their proper application, and to put the parties on a firmer footing with each other with respect to adjustments in rates that may occur in the future.
