**Joint Motion for Suspending
Deadlines Set during the 3/10/09 Hearing**

The City of Danville and the utilities made parties to this proceeding, Parksville Water District, Lake Village Water Association, Inc., and Garrard County Water Association, Inc., hereby request a general suspension of the deadlines set during the 3/10/09 hearing and extended by the Commission's Order dated April 10, 2009. The parties have reached a settlement in principle of their disputes, including over the 2005-2007 purchase power adjustments to rates that affected billings from mid-2005 through mid-2008 that are at issue in this proceeding. They need time now to reduce that settlement in writing and to secure the necessary authorizations for execution of that writing on behalf of the parties; once executed, the agreement(s) will be submitted to the Commission for review and approval and with a request that this proceeding and Case No. 2007-00405 be dismissed by final Order. If the Commission wishes to establish a deadline by which such submission is to be made, the parties respectfully suggest that such a deadline be set to be no earlier than Thursday, May 21, 2009.

WHEREFORE, the parties jointly and respectfully request that the Commission suspend the deadlines set during the 3/10/09 hearing.
