FIRST DATA REQUEST OF COMMISSION STAFF
TO KENTUCKY UTILITIES COMPANY

Kentucky Utilities Company ("KU"), pursuant to 807 KAR 5:001, is to file with the Commission the original and 5 copies of the following information, with a copy to all parties of record. The information requested herein is due on or before August 1, 2008. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.


Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

KU shall make timely amendment to any prior responses if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which KU fails or

refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. Provide copies of Jim Devers' monthly electric bills for his residence at 126 Cherry Hill Drive, Georgetown, Kentucky for the following months: May – August 2004; May – August 2005; May – August 2006; and May – July 2007.
2. Provide copies of any and all correspondence between Mr. Devers and KU relating to the billing issues at Cherry Hill Drive.
3. Provide copies of any and all audio recordings of telephone conversations between Mr. Devers and any representative of KU relating to the billing issues at Cherry Hill Drive.
4. Provide copies of any and all inspection and service records relating to the electric meter at Cherry Hill Drive – meter number C402182-A.
