Dear Director Stumbo:

Pursuant to the Commission's Order dated July 11, 2008, enclosed for filing in the above referenced matter is one original and eleven copies of a Second Supplemental and Amended Response of Windstream Kentucky East, LLC's to Brandenburg Telephone Company's Initial Data Requests to Windstream Kentucky East, LLC and Commission Staff's Data Request to Windstream Kentucky East, LLC, Brandenburg Telephone Company and MCIMetro Access Transmission Services, LLC d/b/a Verizon Access.

Windstream Kentucky East, LLC ("Windstream") demonstrated at the hearing conducted August 19, 2008 that the continued misuse of Windstream's network to accommodate the traffic at issue in this proceeding had and continues to have a significant cost to Windstream. As set forth in Windstream's previous Supplemental Response filed on August 18, 2008, Windstream requested a total of \$1,268,641.00 in additional compensation, itemized as follows:

- \$1,161,809.00 (Usage billed from August 05 to July 08)
- \$ 68,316.00 (Late payment charges on Usage billed from August 05 to July 08)
- \$ 36,299.00 (LNP charges from August 05 to March 07)
- \$ 2,217.00 (Late payment charges on LNP from August 05 to July 08).

As set forth in the attached updated Second Supplemental Response, as of October 2008, this amount has increased to \$1,294,680.00, itemized as follows:

- \$1,197,361.00 (Usage billed from August 05 to October 08)
- \$ 91,812.00 (Late payment charges on Usage billed from August 05 to October 08)
- \$ 36,299.00 (LNP charges from August 05 to March 07)
- \$ 4,758.00 (Late payment charges on LNP from August 05 to October 08)

Fees and charges continue to accrue at a current average rate of \$300 per day.

This issue continues to exist solely because Brandenburg and/or Verizon have chosen to wrongfully route traffic over Windstream's network instead of making proper arrangements for this traffic, including but not limited to entering into an interconnection agreement, and the prior Order in this matter allows them to continue to do so. Brandenburg's continued misuse of Windstream's network, from July 2008 to October 2008 alone, amounted to 6,000,000 minutes

The Commission is again urged by Windstream to order an immediate cessation of this continued misappropriation of Windstream's network, and these two parties should be ordered to uphold their lawful obligations to make appropriate arrangements for exchange of their traffic. Windstream is intentionally and continually being harmed on a daily basis. Further, it appears that neither Brandenburg nor Verizon have any intention to remedy this situation.

Windstream respectfully again asks that the Kentucky Public Service Commission take immediate action in this matter: *i.e.*, that the Commission order that the continued misuse of Windstream's network by Brandenburg and Verizon stop immediately; and that Windstream receive appropriate compensation for the past misuse.
