
Windstream Kentucky East, LLC ("Windstream") supplements as follows in response to the Initial Data Requests; Request No. 13 served by Brandenburg Telephone Company ("Brandenburg") dated July 17, 2008 and the Initial Data Requests; Request No. 1 served by the Commission's Staff dated July 17, 2008.

**RESPONSE: The additional compensation to which Windstream is entitled, calculated through January, 2009, is as follows:**

\$1,225,767.00 (Usage billed from August 05 through January, 2009)  
\$ 168,435.00 (Late payment charges on Usage billed from August 05 through  
January, 2009)  
\$ 36,299.00 (LNP charges from August 05 to March 07)  
\$ 6,029.00 (Late payment charges on LNP from August 05 to January, 2009)  
\$1,436,531.00 TOTAL AMOUNT DUE

For the 4-month period October, 2008 through January, 2009, Brandenburg incorrectly routed an average of approximately 2,000,000 minutes per month across Windstream's network.
