### RESPONSE OF WINDSTREAM KENTUCKY EAST, LLC TO ORDER OF AUGUST 26, 2009

Pursuant to Commission order entered August 26, 2009, Appendix A, Windstream

Kentucky East, LLC ("Windstream") hereby files with the Commission the following detailed

description of its costs for handling the disputed traffic.

Windstream is owed \$1,565,623 as follows:

\$1,302,944 – Usage at \$0.0045 from Aug-05 to Sept 24, 2009

\$218,784 – Interest on amount due

\$36,299 – Amount due for LNP Queries

 $\frac{57,596}{100}$  – Interest on amount due for LNP Queries

\$1,565,623 - Total Due from August 2005 to September 24, 2009

Current average per day is \$291.26 for just the usage.

As noted, Windstream considers Brandenburg to be the principal party responsible for

these amounts, as the traffic arises from Brandenburg customers, and Brandenburg is the party that failed to perform the required LNP queries for the applicable an extended period of time and that performed the translations routing at issue in this case. However, Verizon also shares responsibility because it has benefited from the unauthorized routing of this traffic, and continues to do so, by taking advantage of the unauthorized routing to avoid its responsibility to interconnect with Brandenburg.

Windstream further is attaching hereto discoverable communications per the Commission's request. See Exhibit 1. These communications include some but not all all prior communications by or with the Commission Staff, as such communications are already in its possession.

During a four day audit of traffic in the Elizabeth office, we discovered that Brandenburg Telephone is sending thousands of calls over its ICO trunk groups for calls that do not terminate to Windstream. This is mainly due to the fact that Brandenburg Telephone is not completing LNP queries. Your CLEC originated traffic appears to have already completed the LNP query.

Windstream's Elizabethtown end office completed approximately 12,000 LNP queries, and transited over 866,528 MOU (Minutes Of Use) for calls originated from Brandenburg Telephone.

Since the traffic is intraLATA and your switch is capable, Brandenburg Telephone must complete its own LNP dips, and as the industry standard, route the call based on the LRN.

Brandenburg Telephone needs to complete this work before Friday, February 23, 2007. On Monday, February 26, Windstream will implement the necessary translations changes on the Brandenburg Telephone trunk groups to correct this problem and allow only traffic that has completed the LNP query to terminating to the Windstream Elizabethtown office.

FYI.

On Tuesday, April 3, 2007, translation corrections were completed in the Elizabethtown end office. Calls coming in from Brandenburg must have completed an LNP query, for us to complete or route the call.

A side effect of this change on the Brandenburg ILEC trunk groups, is that since the Brandenburg ILEC and CLEC originate from the same switch, their CLEC must also complete the LNP query before routing to Windstream.

Until Tuesday, Windstream was completing approximately 89,200 LNP queries per month for Brandenburg ILEC, with 99% routing to CLEC Verizon Business.

This is a baby step in the right direction. Brandenburg ILEC is still using the Elizabethtown end office as a tandem to Verizon Business and maybe a few other carriers.

We request that Brandenburg verify their routing accordingly. Also, please start sending and receiving 10-digits on these trunk groups.

George,

As we have discussed, the two existing trunk groups GN056322 and GN056191 are connected to the Radcliff and Elizabethtown end offices.

Since Brandenburg apparently has chosen not to interconnect with the three carriers you mention below, you are sending Windstream the traffic over these end office trunk groups.

I propose that a new trunk group is established to the Elizabethtown tandem. The end office trunk groups appear to be over capacity, and two T1's could be removed from each group.

When the new tandem trunk group is in place, Brandenburg can complete the LNP query, and route the LRN's for the three carriers in question to the Elizabethtown tandem. We will continue to hand the traffic off to the appropriate carrier.

To establish the new tandem trunk group , and move the T1's, the Windstream contact is Jamey Wells. She can be reached at 704-845-7437. She can also help determine the proper capacity and the correct number of T1's to move from each group.

Windstream will continue to transit the Brandenburg originated traffic to these carriers. However, as previously discussed, we cannot continue to take the traffic at the end office.

The email they brought forth doesn't mention blocking or not routing calls. It basically says we will stop completing LNP queries. Brandenburg could turn on LNP queries in a matter of minutes, so 10 days was adequate time. I had informed George that Windstream would continue to take and transit the call after they had completed the LNP query and routed the LRN to Elizabethtown.

They did not include the subsequent email from Wednesday, February 21(attached), or a transcript of the telephone conversations I had with George Lewis, the C.O. Supervisor. The second email changed the tone of the first. George had called and informed me that the two trunk groups between Brandenburg ICO and Elizabethtown, were both end office trunk groups for EAS. One carries EAS between Elizabethtown and Radcliff (their host office), and the other carries EAS between Elizabethtown and Cecilia and their Vine Grove exchange (a remote out of Radcliff). Further checking in Windstream ASAP confirmed that the groups do in fact connect to the Elizabethtown DS0 (end office). This changed the perspective of the situation, since Brandenburg ICO does not have a trunk group to our Elizabethtown 02T (tandem).

Allison Willoby called me today. I returned her call after you and I spoke and again confirmed that we had no intention of blocking anything, but emphasized the point that we were simply asking them in the email to complete LNP queries. However, since the realization that the two existing groups are both to the Elizabethtown end office, it would be in our best interest to establish a trunk group to the Elizabethtown tandem.

Wednesday, February 21, a representative of Verizon Business called me and asked about us blocking Brandenburg traffic. I informed him that we had no intention, but were trying to work out other issues. He indicated that Verizon Business had been trying to interconnect with Brandenburg for around two years, but that they would not come to the table. Brandenburg had informed him that we were going to block the Verizon Business traffic, and to call me to work it out. He said that again, Verizon Business and Brandenburg were at an impasse and had walked away from the interconnection negotiation. Thus, I sent the attached email on February 21.

Since the email, I have discussed with Rich Cinpinski in Network Performance and we were planning to call George with Brandenburg today, in order to start the steps to implement a Brandenburg ICO to Elizabethtown tandem trunk group. I even received confirmation from Transport, that enough vacant facilities exists. I received your call before we could call George. The goal is to have them complete the LNP query, and then route the LRN to the Elizabethtown tandem. In previous emails and conversation, I confirmed to George that we would continue to hand off the call to the carriers they did not have interconnection to.

Dear John:

This letter is a follow up to our conversations today regarding Windstream's concerns with Brandenburg regarding LNP queries. As discussed, Windstream will not implement the translation changes on Brandenburg Telephone's trunk groups on February 23, 2007 as indicated in Mr. Williams' February 15, 2007 e-mail to Mr. Nevitt. Windstream will continue working with Brandenburg's operations and trusts that Brandenburg will cooperate in that effort to expeditiously resolve the situation.

It is my understanding this is a long-standing issue and Brandenburg needs to take immediate steps to resolve it. To that end, Windstream requests that Brandenburg promptly work with Windstream to identify a reasonable date by which Brandenburg can commit to resolving the issue.

Although Brandenburg indicated that 10 days was not adequate time, Windstream advises me that Brandenburg can initiate the LNP query function in a matter of minutes. Therefore, Windstream needs to understand Brandenburg's need for a longer period and will work with Brandenburg to bring about prompt resolution of this issue.

This message is a follow up our conversation Wednesday morning, since you suggested that we put our request in writing. The request had already been conveyed in conversations over the phone and through email starting over three weeks ago.

During a four day audit of traffic in the Elizabethtown office, Windstream discovered that our Elizabethtown end office completed approximately 12,000 LNP queries, and transited over 866,528 MOU (Minutes Of Use) for calls originated from Brandenburg Telephone. The query is being completed at Windstream's Elizabethtown end office and then the call is tandemed to other carriers, contrary to the proper use of the Elizabethtown end office.

Windstream's Elizabethtown end office is not established as, recognized in the industry as, or otherwise to be used as a LATA tandem. Brandenburg is not authorized to use Windstream's end offices to tandem/transit calls. In compliance with the industry standard, Brandenburg is directed to send only traffic to the Elizabethtown end office, that terminates to Windstream in that office. That was the original purpose of these end office trunk groups.

Since the traffic is intraLATA and your switch is capable, Brandenburg Telephone must complete its own LNP dips, and as the industry standard, route the call based on the LRN. As discussed several times over the last four years, we request that Brandenburg work with Windstream to establish a trunk group to the Elizabethtown tandem. The tandem will take the LRN and route the call to the proper carrier.

A traffic study indicates that at least two T1's can be removed from both end office trunk groups, GN056322 and GN056191, and the four T1's used to establish the tandem trunk group. No additional facilities will be required. These changes can be completed now in a matter of minutes.

On the call Wednesday morning, we included our Network Performance engineers so that we could work with your engineers and coordinate these changes. We do not understand why Brandenburg is not willing to accommodate this request, or why Brandenburg wants to delay this error any longer.

A conference call was held August 16, 2002 in which you participated, and this transit issue was discussed. The parties agreed that we were discussing trunking and billing questions from a CLEC perspective. However, since you represent Brandenburg ILEC interests as well as CLEC interests, Brandenburg was well aware of the issue from an ILEC perspective.

And when Dave Kunkler called me on May 28, 2004 with Brandenburg ILEC issues, Windstream agreed to transit the traffic for Brandenburg, but requested that Brandenburg establish direct trunks to the carrier, or to establish a tandem trunk group to the Elizabethtown tandem.

Further, as Brandenburg is aware, the level of traffic was at a DS3 level (*i.e.*, well in excess of a DS1 level), although Brandenburg did not establish a direct connection for delivery of the traffic. Windstream, to no avail, repeatedly attempted to work with Brandenburg regarding this traffic.

The calls in question arose when Brandenburg's end users accessed the Internet by calling dial-up ISPs served by Verizon Business. The traffic had no impact on local, long-distance, or EAS traffic flowing between the ILEC and Windstream, <u>including no impact</u> to 911 calls which are routed over separate facilities.

Upon information and belief, Brandenburg appears to have routed the traffic through Windstream's Elizabethtown end office instead of establishing a business relationship with Verizon Business for the termination of this ISP traffic.. Brandenburg also denied reimbursement to Windstream for the use of Windstream's network to deliver the traffic. Brandenburg is aware that the NPA-NXX used by Verizon Business is homed behind the Louisville tandem. Therefore, Brandenburg should have routed the traffic from its tandem to the Louisville tandem. Instead, Brandenburg continued to route the traffic to Windstream's end office in Elizabethtown. To remedy the situation, Brandenburg may perform approximately 15 minutes of translations coding to route the ISP traffic destined for Verizon Business through the Louisville tandem, or Brandenburg may establish a direct connection to Verizon Business for delivery of the traffic. However, Brandenburg may not use Windstream's Elizabethtown end office to deliver the DS3 level of ISP traffic to Verizon Business, which is homed behind the Louisville tandem.

### RE: Brandenburg Telephone Co. dispute with Windstream Kentucky East—Call Blocking affecting Local Service Customer of Verizon Access—Request for Emergency Hearing

Dear Ms. Stumbo:

We are counsel to Verizon Access, a competitive local exchange carrier. Verizon Access requests an immediate emergency order by the Commission to stop the improper blocking of Internet access traffic by Windstream. Windstream has taken this action in connection with a billing dispute with Brandenburg Telephone Company. This blocking has severe and immediate adverse effects on third parties by preventing America Online customers in Brandenburg's service territory from connecting with the Internet through their chosen provider, AOL.

This morning I received a copy of Daniel Logsdon's letter to you dated June 2, 2008. That letter alleges "misuse" of a Windstream end office by Brandenburg Telephone Company. It appears that rather than first bringing the dispute to the Commission<sup>1</sup>, Windstream chose to block traffic in an effort to force Brandenburg Telephone Company to pay a disputed bill for transit service. This has created an urgent, customer-affecting situation. Verizon Access asks that the Commission convene an emergency hearing to consider the issues raised by Mr. Logsdon's letter.

<sup>1</sup> The Commission has made clear that a carrier considering disconnection over an inter-carrier dispute should bring the matter to the Commission well before any action which could interfere with the service of an end user. See Customer Billing and Notice Requirements, Case No. 2002-00310, Order at 7-8 (May 20, 2003).

Regardless of the merits of the dispute between these incumbent providers, the Commission should understand the immediate customer effects of what Windstream has done and what, so far, Brandenburg Telephone Company has failed to remedy. Brandenburg Telephone Company customers who use America Online ("AOL") as their Internet service provider are currently unable to access the Internet via a local call to the AOL dial-up number which serves them (via a number associated with the Elizabethtown rate center). That dial-up number is provided by Verizon Access. Brandenburg Telephone Company customers unable to access the Internet are likely to attribute the network problem to AOL. Brandenburg Telephone Company is also a direct competitor to AOL for Internet access service.

In its letter Windstream claims that Brandenburg could "remedy the situation" in approximately 15 minutes by routing the affected traffic to AT&T Kentucky's Louisville tandem. Given the ease at which this blocking could be ended, Verizon Access asks that the Commission exercise its powers under KRS 278.040 to enforce KRS 278.520 and issue an immediate emergency order to cease the blocking of traffic. Verizon Access also asks the Commission to promptly convene an emergency hearing at which Windstream could explain why it knowingly blocked the traffic of another carrier without first contacting the Commission. At that hearing Brandenburg could explain why it has not taken immediate action to restore the ability of its local customers to reach their Internet service provider of choice.

The purpose of this letter is to provide a courtesy notice to the Commission that as of 9:00 a.m., Monday, June 2, 2008, Windstream Kentucky East, LLC ("Windstream") ceased the misuse of its Elizabethtown end office by Brandenburg Telephone ("Brandenburg" or the "ILEC") to route ISP traffic that otherwise should have been routed through AT&T's Louisville tandem. Further, as Brandenburg is aware, the level of traffic was at a DS3 level (*i.e.*, well in excess of a DS1 level), although Brandenburg did not establish a direct connection for delivery of the traffic. Windstream, to no avail, repeatedly attempted to work with Brandenburg regarding this traffic.

The calls in question arose when Brandenburg's end users accessed the Internet by calling dial-up ISPs served by Verizon Business. The traffic had no impact on local, long-distance, or EAS traffic flowing between the ILEC and Windstream, <u>including no impact</u> to 911 calls which are routed over separate facilities.

Upon information and belief, Brandenburg appears to have routed the traffic through Windstream's Elizabethtown end office instead of establishing a business relationship with Verizon Business for the termination of this ISP traffic.. Brandenburg also denied reimbursement to Windstream for the use of Windstream's network to deliver the traffic. Brandenburg is aware that the NPA-NXX used by Verizon Business is homed behind the Louisville tandem. Therefore, Brandenburg should have routed the traffic from its tandem to the Louisville tandem. Instead, Brandenburg continued to route the traffic to Windstream's end office in Elizabethtown. To remedy the situation, Brandenburg may perform approximately 15 minutes of translations coding to route the ISP traffic destined for Verizon Business through the Louisville tandem, or Brandenburg may establish a direct connection to Verizon Business for delivery of the traffic. However, Brandenburg may not use Windstream's Elizabethtown end office to deliver the DS3 level of ISP traffic to Verizon Business, which is homed behind the Louisville tandem.







# JEB:

The unauthorized use of Windstream's network continues in violation of industry routing protocols, as well as the Commission's own precedent for establishment of direct facilities for traffic exceeding a DS1 level. Brandenburg improperly continues to route a DS3 level of calls over EAS trunks to Windstream's Elizabethtown End-Office. These calls, which are not destined for Windstream's network or facilities located behind Windstream's network, can and should be immediately routed to the Louisville tandem. Windstream intends to hold all culpable parties responsible for damages with respect to the continued misappropriation of Windstream's facilities. Currently, Windstream estimates that in addition to past damages it continues to incur damages of at least \$500 per day that the unauthorized routing is allowed to continue.

Windstream is not a party to or otherwise privy to the negotiations between MCI/Metro and Brandenburg. Nevertheless, almost two weeks have elapsed since Brandenburg expressly stated on June 5, 2008 that an interconnection agreement with MCI/Metro was imminent and could be reached within 7-14 days. If an agreement is not reached by June 19, 2008 (fourteen days from June 5, 2008), Windstream requests the Commission to use its full authority, including penalties or Commission-ordered expedited mediation with MCI/Metro, to force Brandenburg to take all steps necessary to cease the improper use of Windstream's faculties no later than noon on July 3, 2008 - which is twice the length of time Brandenburg stated was necessary to finalize its agreement with MCI/Metro.

After the June 5 phone conference among the carriers and the PSC staff, Verizon Business ("VZB") made a proposal to Brandenburg and sent it directly to the company by email on Friday, June 6. VZB proposed a 50/50 split of the total expense for interconnection and a bill and keep arrangement for the traffic originating from Brandenburg's customers in Radcliff. Under this proposal VZB would accept the traffic at the Windstream tandem in Elizabethtown. However, VZB has been willing to accept the traffic at the BellSouth tandem in Louisville, under the same arrangement, i.e. split of the expense for total expense for interconnection and bill and keep arrangement.

Brandenburg rejected this proposal.

On June 5, counsel for Brandenburg had contacted me and asked that we stay in touch concerning negotiations between the companies. Accordingly, we had calls on June 12 and June 18. During both calls we discussed VZB's proposal. VZB's in-house interconnection attorney, John Monroe, participated in the call on June 12.

On June 19 counsel to Brandenburg stated that the VZB proposal was not acceptable. In addition, counsel to Brandenburg stated that in the near future Brandenburg would make changes in its network to prevent its customers from dialing the VZB numbers on a local basis. Such a change would be unlawful, and would interfere with Radcliff customers' ability to access AOL.

On Tuesday, April 3, 2007, translation corrections were completed in the Elizabethtown end office. Calls coming in from Brandenburg must have completed an LNP query, for us to complete or route the call.

A side effect of this change on the Brandenburg ILEC trunk groups, is that since the Brandenburg ILEC and CLEC originate from the same switch, their CLEC must also complete the LNP query before routing to Windstream.

Until Tuesday, Windstream was completing approximately 89,200 LNP queries per month for Brandenburg ILEC, with 99% routing to CLEC Verizon Business.

Here is confirmation from Kay that the calls from Brandenburg to E-town are transiting the E-town end office to Verizon Business on a local interconnection group. This is the exact call scenario we discussed when setting up the End Office Transit rate in the KY Local Transit tariff. I agree that Brandenburg should not be sending the calls to the E-town end office, but that is why we decided to bill a higher rate so they would move any transit traffic to the tandem.
