ORDER

On June 18, 2008, Jessamine South Elkhorn Water District ("Jessamine South Elkhorn") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Jessamine South Elkhorn purchases water from the city of Nicholasville ("Nicholasville") and Kentucky-American Water Company ("KAWC").
2. Nicholasville has notified Jessamine South Elkhorn that, as a result of an increase in the water withdrawal fees that the Kentucky River Authority ("KRA") assesses to Tier II users, Nicholasville is increasing its wholesale rate from \$1.81 per 1,000 gallons to \$1.85 per 1,000 gallons effective June 29, 2008.
3. KAWC has notified Jessamine South Elkhorn that, as a result of an increase in the water withdrawal fees that KRA assesses to Tier II users, KAWC is increasing its charge to recover the KRA withdrawal fee from \$0.00113 per 1,000 gallons to \$0.08323 per 1,000 gallons of water effective April 1, 2008.
4. Jessamine South Elkhorn proposes a purchased water adjustment factor of \$0.10 per 1,000 gallons.

5. During the 12-month period ending March 2008, Jessamine South Elkhorn purchased 292,776,000 gallons from KAWC and 27,488,600 gallons from Nicholasville and sold 320,264,600 gallons. The increase in the cost of purchased water is \$25,136.45, resulting in a purchased water adjustment factor of \$0.10 per 1,000 gallons.

6. The purchased water adjustment factor of \$0.10 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Jessamine South Elkhorn are approved.
2. The purchased water adjustment factor of \$0.10 per 1,000 gallons as calculated in Appendix A is approved.
3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for service rendered on or after July 5, 2008.
4. Within 20 days of the date of this Order, Jessamine South Elkhorn shall file with the Commission revised tariff sheets showing the rates approved herein.
