ORDER

On June 13, 2008, Kirksville Water Association ("Kirksville Water") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Kirksville Water purchases water from Richmond Utilities ("Richmond Utilities").
2. On March 31, 2008, Richmond Utilities notified Kirksville Water that, effective April 1, 2008, its Kentucky River Authority ("KRA") withdrawal fee charge to Kirksville Water would increase from \$0.04 per 100 cubic feet of water to \$0.065 per 100 cubic feet.
3. Kirksville Water proposes a factor of \$0.04 per 1,000 gallons for its customers, effective June 30, 2008.
4. The purchased water adjustment factor of \$0.04 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. Kirksville Water's proposed rates are approved.

2. The purchased water adjustment factor of \$0.04 per 1,000 gallons as calculated in Appendix A is approved.


3. The rates set forth in Appendix B are fair, just, and reasonable and are approved for service that Kirksville Water renders on or after June 30, 2008.
