ORDER

On June 16, 2008, North McLean County Water District (“North McLean”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. North McLean purchases water from the West Daviess County Water District (“West Daviess”), city of Calhoun (“Calhoun”) and city of Livermore (“Livermore”).

2. West Daviess notified North McLean that, effective with its July 10, 2008 billing, the wholesale rate would increase from \$2.13 per 1,000 gallons to \$2.26 per 1,000 gallons. West Daviess charges a \$0.67 per 1,000 gallons surcharge to North McLean in addition to the wholesale rate.<sup>2</sup>

3. North McLean proposed a purchased water adjustment factor of \$0.02 per 1,000 gallons.

4. During the 12 months ended April 2008, North McLean purchased 13,420,400 gallons of water from West Daviess, 119,066,500 gallons from the city of Calhoun, 2,567,900 from the city of Livermore, and it sold 112,284,600 gallons. The increase in the cost of purchased water is \$1,744.65, resulting in a purchased water adjustment factor of \$0.02 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.02 per 1,000 gallons is fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. The rates proposed by North McLean are approved.
2. The purchased water adjustment factor of \$0.02 per 1,000 gallons as calculated in Appendix A is approved.
3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after July 10, 2008.
4. Within 20 days of the date of this Order, North McLean shall file with the Commission revised tariff sheets showing the rates approved herein.
