O R D E R

Frankfort Electric and Water Plant Board ("Plant Board") proposes to adjust its existing rates for wholesale water service to public utilities effective on and after July 7, 2008. On July 2, 2008, the Commission suspended the Plant Board's proposed rate and issued a procedural schedule. On August 19, 2008, the Commission scheduled an informal conference and suspended the initial procedural schedule. At the informal conference on August 21, 2008, Commission Staff and the parties in attendance agreed to have an initial round of data requests and re-evaluate the status of the case after the Plant Board responded to those requests. Accordingly, the Commission entered a procedural schedule to establish deadlines for those data requests and responses.

After responding to the first set of data requests, the Plant Board filed a request for an informal conference and a request for hearing. In response to the Plant Board's requests, Intervenors North Shelby Water Company and U.S. 60 Water District requested additional time for discovery and stated that "an informal conference may result in an agreed resolution to this matter" after additional discovery is conducted. Intervenors Elkhorn Water District and Peaks Mill Water District requested in their response that an informal conference be held prior to a formal hearing.

The Commission finds it appropriate to permit the Intervenors and Commission Staff an opportunity to make additional data requests and to schedule an informal conference.


IT IS THEREFORE ORDERED that:

2. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
3. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
