ORDER



IT IS HEREBY ORDERED that:

1. The motion of Elkhorn to intervene is granted.
2. Elkhorn shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
3. Should Elkhorn file documents of any kind with the Commission in the course of these proceedings, Elkhorn shall also serve a copy of said documents on all other parties of record.
