Box 11610, Lexington, KY 40576, by counsel, and for their joint response to the Data Requests served upon them by the Company, state as follows:

**Data Request No. 1**

To the extent not previously provided, please provide electronic copies (on CD) of all workpapers and supporting documentation used and relied upon by Community Action Kentucky, Inc. and Community Action Council for Lexington-Fayette, Bourbon, Harrison and Nicholas Counties, Inc. in preparation of its testimony. Please provide all electronic spreadsheets with cell formulas, cell references, macros and VBA code intact.

**Response**

Witness: Jack Burch:

Attached to the e-mail accompanying this hard copy, please find scanned PDF copies of two reports from the Council's Intake Referral Information System (IRIS) database reflecting enrollment status for the Kentucky Utilities Home Energy Assistance program. These papers

were used to indicate the demand for the program and wait list at the time testimony was written. Also attached is a spreadsheet (which is included in the testimony) which indicates company contributions, ratepayer contributions and number of ratepayer contributors for the Wintercare Energy Fund. This chart was constructed from data provided in the Companies' response to data requests from Community Action Council in this case.

All other information in Mr. Burch's testimony is derived from his own knowledge of the Council's programming or was directly typed from the Council's IRIS database or, in the case of Census data, from the Census.gov Web site. Therefore, no other workpapers exist as requested.

#### **Data Request No. 3**

Please provide according to each fiscal year, the base, contingency and total amount of Low Income Home Energy Assistance Program ("LIHEAP") funds allocated to Kentucky from 2000 through 2009.

#### **Response**

Witness: Kip Bowmar:

Below you will find Kentucky's LIHEAP benefit allocations for 1999-2000 to 2008-2009. 2005-2006 contains \$10 million in state funding; 2006-2007 contains \$14 million in federal supplemental funding; 2007-2008 contains \$6 million in summer cooling for August thru October 2007. 2002-2003 contains \$5 million in summer cooling. This information was cut and pasted from an excel spread sheet and no other information was used in the preparation of the report.

**Data Request No. 4**

Please describe what, if any, financial contributions are made by the Commonwealth of Kentucky for the purpose of funding any LIHEAP type of assistance to low income households.

**Response**

Witness: Kip Bowmar:

In the 2005-2006 heating season, the Kentucky General Assembly appropriated \$10 million to supplement the LIHEAP Program. This remains the only time that Kentucky General Assembly dollars have been used to supplement the program. Legislation in 2008 was stalled due to budgetary concerns.

**Data Request No. 5**

Please describe the actions by the Community Action Kentucky, Inc. and Community Action Council for Lexington, Fayette, Bourbon, Harrison and Nicholas Counties, Inc., to encourage or persuade federal or state legislatures to maintain or increase LIHEAP funding for each fiscal year.

**Response**

Witness: Jack Burch:

Community Action Council, through a privately supported legislative fund, provides financial support to the National Community Action Foundation (NCAF), which advocates at the federal level for LIHEAP and other community action programming. Community Action Council also pays membership dues to Community Action Kentucky, which performs the same function at the state level. Finally, Executive Director Jack Burch personally advocates for LIHEAP and other programming which accrues to the benefit of the low-income constituents of the organization.

Witness: Kip Bowmar:

Community Action Kentucky and its member agencies also support the National Community Action Foundation, which advocates for federal level LIHEAP and other Community Action programming. In addition, Community Action Kentucky communicates with the Kentucky Congressional delegation about the need for and impact of LIHEAP in Kentucky. Community Action Kentucky actively lobbies the Kentucky General Assembly for additional resources for LIHEAP.

**Data Request No. 6**

Please state whether the recently announced increase in LIHEAP funds for Kentucky this year will allow additional low-income households to benefit and if so the number of additional households that will benefit compared to the number of households that benefited from available LIHEAP funds last year.

**Response**

Witness: Kip Bowmar:

In 2007-2008, Community Action Kentucky's 23 member Community Action Agencies served approximately 45,000 fewer families in 2007-2008 than in 2005-2006 and 2006-2007 because of fewer federal and state resources. The additional dollars in 2009 will allow us to serve those families. In addition, due to rising fuel price costs we were able to raise subsidy benefits by 40% and to increase crisis benefits for electric and natural gas. Those steps were necessary as a study by Community Action Kentucky in 2008 found that the amount of arrearages owed to investor owned utilities by residential customers grew during the first four months of 2008 by 25% compared to the first four months of 2007. We anticipate that in addition to the 45,000 families that were turned away in 2007-2008, we will be able to serve an additional 20,000 families. The unmet need, however, far outstrips even the additional dollars added. We estimate that based on Census estimates of the number of Kentuckians living below the poverty line, there will still be another 50,000 families that we will not have the resources to serve even in a year where LIHEAP funding was doubled.


Witness: Jack Burch:

While increases in LIHEAP funds for 2008-2009 are allowing Community Action Council to serve additional households, these funds are serving only to reduce the number of unmet requests for assistance. In 2007-2008 the LIHEAP Crisis component closed in February – the earliest it has closed in many years – leaving hundreds of families without assistance in the Council’s service area. The rising costs of food, gasoline, medical care, rent and other necessities have further eroded the ability of families to keep up with home energy bills. So while an increase in LIHEAP allows the Council to serve more people, an equal or greater increase has taken place in the number of people in need of assistance, therefore reducing or eliminating the impact of any increase.

It is also important to note the substantial difference between the LIHEAP program and the Kentucky Utilities Home Energy Assistance (HEA) program. The LIHEAP program provides a one-time subsidy in the fall followed by an emergency crisis component in the winter to prevent families who are behind on their payments from going without heat for the winter. The HEA program provides subsidies during the peak winter heating and summer cooling months to prevent families from falling behind in the first place, therefore reducing the need for assistance programs such as LIHEAP.



## Jack E. Burch

Jack Burch has served as the Executive Director of Community Action Council for Lexington-Fayette, Bourbon, Harrison and Nicholas Counties since 1979. The Council sponsors a comprehensive range of anti-poverty programs and strategies. Current services and programs include social and economic self-sufficiency initiatives; child, youth and family development; energy assistance and conservation; food and other forms of emergency assistance; and, housing development and management. Jack is also the CEO of Community Action Council's housing and economic development corporations.

In addition to direct services, the Council's primary goals also include advocacy and the development of social capital in low-income communities. The Council provides services to over 20,000 persons annually. It has approximately 280 employees and an annual budget of approximately \$21,000,000. Funding support of the Council's activities is provided by a wide range of sources, including the federal, State and local governments, Columbia Gas of Kentucky and Kentucky Utilities Company, Ford Foundation, Knight Foundation, Chase Bank Foundation and individual donors.

Jack was a member of the first class of Certified Community Action Professionals (CCAP) in 1993, a national credential awarded to persons recognized as leaders on anti-poverty issues and programs in the United States. In 2003, Community Action Council received the Excellence in Community Action Award. It is one of the first four community action agencies to receive the award. The Council was also recognized as a Head Start Program of Excellence in 2000 and again in 2004 and was named Outstanding Head Start Grantee in 2005.

Jack is the founder and CEO of WinterCare Energy Fund, the nation's first privately funded, state-wide energy assistance fund. He initiated Community Action Council's first utility rate case intervention to ensure the needs of the utility's low-income customers were represented. That and subsequent interventions have resulted in several millions of dollars in savings and benefits for low-income utility customers.

Jack has served on various task forces and committees to develop and promote the Results Oriented and Management Accountability (ROMA) process for the nation's community action agencies. He has served as a reviewer for training and technical assistance grants for the Department of Health and Human Services, and for the Excellence in Community Action award. He currently serves on the national Community Action Partnership's Training and Technical Assistance Task Force.

Jack serves on a number of local boards and commissions, including Chairperson of Fayette County Public Schools' Equity Council, the Lexington Partnership for Workforce Development, Lexington's Affordable Housing Trust Commission, Lexington's Commission on Financial Lending Practices, and, Success By Six, a community-wide child development initiative. He presently chairs a community effort to redevelop the former Russell Elementary School property to preserve its historic and cultural significance for Lexington's African-American community.

**He is a native of Memphis, Tennessee. He received his BA from Rhodes College where he was a P.K. Seidman Scholar in economics and has completed his post graduate studies in economics at Vanderbilt University and the University of the West Indies. Prior to joining Community Action Council, Jack served on the staff of the Peace Corps in both Washington and West Africa and as President of a consortium of colleges in Eastern Kentucky.**
