ORDER

On January 9, 2009, Kentucky Utilities Company ("KU") filed a petition for approval to deviate from the Commission's regulation, 807 KAR 5:011, Section 8(5), regarding publication of notice of the public hearings on its current rate change application. 807 KAR 5:011, Section 8(5), provides:

Where notice pursuant to KRS 424.300 is published by the applicant in a newspaper, it shall be published in a newspaper of general circulation in the areas that will be affected one (1) time not less than seven (7) nor more than twenty-one (21) days prior to the hearing giving the purpose, time, place and date of hearing.

KU states in its petition that, on or before January 1, 2009, it timely published notice of the January 6, 2009 public meeting in Madisonville, Kentucky; the January 8, 2009 public meeting in Middlesboro, Kentucky; the January 12, 2009 public meeting in Lexington, Kentucky; and the January 13, 2009 evidentiary hearing at the Commission's offices in Frankfort, Kentucky. The notice was published in the *Lexington Herald-Leader* and *Louisville Courier-Journal* and 90 other newspapers throughout its service area. However, KU states that due to administrative errors on the part of two

newspapers, The Manchester Enterprise (a weekly newspaper serving Clay County) and the Barbourville Advocate Messenger (a weekly newspaper serving Knox County), notice of the public meetings and January 13, 2009 evidentiary hearing was not published in those newspapers until January 8, 2009—the day of the public meeting in Middlesboro and only five days prior to the evidentiary hearing on January 13, 2009.

Pursuant to 807 KAR 5:011, Section 14, the Commission finds good cause under the facts of this case to grant KU's request for deviation from the requirements of 807 KAR 5:011, Section 8(5). KU provided sufficient notice of the January 8, 2009 public meeting and the January 13, 2009 formal administrative hearing on KU's rate increase application through its publication of the notice in the Lexington Herald-Leader and Louisville Courier-Journal—the two newspapers of largest circulation in Kentucky.

IT IS THEREFORE ORDERED that KU's petition for deviation from the notice requirements of 807 KAR 5:011, Section 8(5), is granted.
