**MOTION OF KENTUCKY UTILITIES COMPANY  
TO CONSOLIDATE PROCEEDINGS**

Kentucky Utilities Company (“KU”), by counsel, moves the Public Service Commission of Kentucky (“Commission”) to consolidate *In the Matter of: An Adjustment of the Electric Rates, Terms and Conditions of Kentucky Utilities Company*, Case No. 2008-00251, with *In the Matter of: Application of Kentucky Utilities Company to File Depreciation Study*, Case No. 2007-00565. The grounds supporting this motion are set forth below.

On December 28, 2007, KU and Louisville Gas and Electric Company (“LG&E”) (collectively, the “Companies”) filed with the Commission depreciation studies and applications asking the Commission to implement new depreciation rates for the Companies during their next general rate proceedings. On July 1, 2008, KU notified the Commission in writing of its intention to seek an adjustment of its electric base rates and tariff terms and conditions.

The consolidation of these two proceedings will facilitate the Commission’s review of and decision in these cases. There will be common issues of fact raised in both proceedings, and the determination of appropriate depreciation rates for KU will impact both proceedings. In the interests of administrative economy, to avoid unnecessary duplication of effort, and to prevent

the unnecessary expenditure of resources by the Commission, as well as the parties, KU submits that the consolidation of the above-captioned proceedings is reasonable.


Furthermore, the Attorney General has indicated his support for consolidating these proceedings, having stated in his June 6, 2008, motion in Case No. 2007-00565, “[T]he Attorney General agrees with the companies that combining the instant cases with the upcoming rate cases would promote judicial economy and administrative efficiency ....”

**WHEREFORE**, Kentucky Utilities Company respectfully moves the Public Service Commission to issue an order:

1. Consolidating Case No. 2007-00565 with and into Case No. 2008-00251;
2. Incorporating the record in Case No. 2007-00565 into the record of Case No. 2008-00251;
3. Closing Case No. 2007-00565; and
4. Establishing the current procedural schedule of Case No. 2008-00251 as the procedural schedule for the consolidated proceeding.
