On October 10, 2008, Louisville Gas and Electric Company ("LG&E") and its affiliate, Kentucky Utilities Company ("KU") filed a joint motion requesting the Commission to reinstate the procedural schedules issued on August 29, 2008. Those procedural schedules provided for public hearings on December 9, 2008 in the above-captioned LG&E cases and the companion KU cases.<sup>1</sup> The Commission, having considered the motion with respect to these LG&E cases and the responses thereto, hereby finds that the revised procedural schedule issued on October 6, 2008, which provides for a hearing on January 13, 2009 in these LG&E cases, should remain in effect to provide sufficient time for the scheduling of meetings to gather public input prior to the public hearing.
