ORDER

On June 11, 2009, the Commission issued an Order in this proceeding which granted in part and denied in part SouthEast Telephone, Inc.'s ("SouthEast") motion to incorporate additional issues in the July 14, 2009 formal hearing. Specifically, the Commission granted SouthEast's request to incorporate the issue concerning installation charges versus conversion charges for lines converted to commingled elements. However, the Commission denied SouthEast's request to incorporate the issue concerning the qualifiers and limitations placed on commingling orders by the defendant, BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky").

On June 15, 2009, SouthEast moved for reconsideration of the Commission's decision to exclude the issue concerning the qualifiers and limitations placed on

commingling orders by AT&T Kentucky. On June 22, 2009, AT&T Kentucky submitted a response in objection to the motion.

The Commission has reviewed the pleadings in this matter and finds that, pursuant to KRS 278.400, SouthEast has failed to offer any evidence on the question of the incorporation of this issue which could not have been presented in the motion for incorporation. The motion for reconsideration has not persuaded the Commission to integrate the issue regarding qualifiers and limitations on commingling orders into the formal hearing. Therefore, SouthEast's motion is denied and the June 11, 2009 Order shall stand, as issued.

IT IS HEREBY ORDERED that SouthEast's motion for reconsideration is denied.
