JOINT MOTION FOR AN EXTENSION OF TIME TO COMPLY WITH THE COMMISSION'S ORDER OF OCTOBER 7, 2009 CONCERNING THE FILING OF FACT STIPULATIONS

The parties to this action, Insight Phone of Kentucky, LLC, Windstream Kentucky East, LLC and Windstream Kentucky West, LLC, by counsel, jointly move for an extension of time of two-weeks to comply with the Commission's Order of October 7, 2009. In its Order of October 7, 2009, the Commission ordered the parties to, among other things, "jointly file a clear and concise list of stipulated facts" within thirty (30) days of the date of the Order being entered. The parties have since filed joint motions for extensions of time to comply with the Commission's Order. The parties submit that they are still working to develop a complete list of stipulated facts, and that they are optimistic that additional time devoted to this end will ultimately be the best use of the parties' and the Commission's resources. An extension of an additional week will allow the parties more time to produce a joint list of stipulated facts in as comprehensive a manner as possible. Accordingly, the parties request that the Commission grant an extension through December 21, 2009 for the parties to comply with the October 7, 2009 Order.
