Dear Mr. Johnson:

Earlier this year, U.S. 60 Water District (the "District") implemented new water rates approved by Rural Development. Those rates included, for the first time ever, a fire hydrant rental in the amount of \$5.00 per month per hydrant to be paid by fire districts, and rental for private parties of \$5.00 per month per hydrant. This charge created a political firestorm and the District was requested to eliminate this charge.

The main reason for instituting this charge was to recoup the cost of water used by the District in firefighting and especially in training. More importantly, many fire departments have refused to comply with the District's request that they report such usages to the District so that it can consider those water quantities in its water loss reports to PSC. Accordingly, the District decided to replace the hydrant rental fee with a formal requirement that fire departments report to the District water usage for these purposes, require the fire departments to refrain from using water for training purposes during water shortage conditions, and implement a penalty and a charge for water consumed if the fire department does not comply with the reporting requirements. This is a rule favored by the Kentucky Public Service Commission ("PSC").

The District's CPA has reviewed the District's finances and concluded that the elimination of the \$5.00 per month hydrant rental fee will not impact the District's financial circumstances in any significant way. Additionally, the District has significant reserve funds to offset any possible impact.

The District has submitted this proposed tariff to the PSC for approval. I enclose a copy of the proposed regulation for your review. PSC has requested the District to obtain a letter from Rural Development concurring with this change in the District's tariffs.

In addition to the above, the District requests permission to eliminate the Woodlawn Project waterline construction surcharge imposed on certain customers in 1993. As you may recall, it was originally scheduled to continue for approximately 20 years. I enclose a copy of the Motion which was filed by the District with the PSC regarding this matter.

As you will see from the Motion, the surcharge was originally used because the District was very low in unrestricted cash and was unable to contribute any significant funds to the project. In contrast, the District now has over \$850,000.00 in unrestricted funds. The customers have paid most of the construction costs through their surcharges over the last 15 years. The District wishes to pay off the remaining portion of the surcharge loan in the amount of \$63,354.25 from its unrestricted funds. PSC has likewise requested a letter of concurrence from Rural Development regarding this matter.

Incidentally, several years from now, the District intends to ask Rural Development and PSC for permission to pay off and eliminate its remaining surcharge, after it has also been in effect for 15 years, although that request is not a portion of this request. We are providing you with notice of this intention so that you will know we are treating all of our customers the same.
