O R D E R

Meade County Water District ("Meade District") has applied to the Commission for a Certificate of Public Convenience and Necessity to construct and finance a water storage tank and water mains. Meade District has requested a deviation from 807 KAR 5:001, Section 11(2)(a), which requires the filing of a financial exhibit covering "operations for a twelve (12) month period . . . ending not more than ninety (90) days prior to the date the application is filed."¹ Meade District has provided its financial statements for calendar year 2007 and represents that there has been no change that is material in nature in its financial condition or operation since the publication of these statements. 807 KAR 5:001, Section 14, permits deviations from the regulations for good cause. Meade District has demonstrated that good cause exists to permit its deviation from 807 KAR 5:001, Section 11(2)(a).



IT IS THEREFORE ORDERED that Meade District's request for deviation from the filing requirements of 807 KAR 5:001, Section 11(2)(a), is granted.
