ORDER

On October 8, 2008, Big Sandy Water District (“Big Sandy”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Big Sandy purchases water from the city of Louisa (“Louisa”), city of Kenova (“Kenova”), Rattlesnake Ridge Water District (Rattlesnake Ridge”) and the Cannonsburg Water District (“Cannonsburg”).

2. Louisa notified Big Sandy that, effective July 23, 2008, its wholesale rate to Big Sandy would increase from \$2.20 per 1,000 gallons to \$2.32 per 1,000 gallons.

3. Big Sandy proposed a purchased water adjustment factor of \$0.05 per 1,000 gallons.

4. On October 15, 2008, Big Sandy amended its application to correct an error regarding the amount of gallons purchased by Big Sandy from Louisa. The corrected purchases result in a decrease to the proposed purchased water adjustment factor.

5. Big Sandy proposed an effective date of November 1, 2008. As KRS 278.180(1) requires a utility to provide 30 days' notice to the Commission of any proposed rate adjustment, and as Big Sandy failed to provide such notice, the proposed adjustment cannot become effective on November 1, 2008.

6. During the 12 months ended September 30, 2008, Big Sandy purchased 77,265,100 gallons of water from Louisa, 211,828,000 gallons from Kenova, 4,078,300 gallons from Rattlesnake Ridge, and 58,816,000 gallons from Cannonsburg, and it sold 256,152,400 gallons. The increase in the cost of purchased water is \$9,271.81, resulting in a purchased water adjustment factor of \$0.04 per 1,000 gallons.

7. The purchased water adjustment factor of \$0.04 per 1,000 gallons is fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. Big Sandy's proposed rates are denied.
2. The purchased water adjustment factor of \$0.04 per 1,000 gallons as calculated in Appendix A is approved.
3. The rates in Appendix B are fair, just, and reasonable and are approved for services on or after November 7, 2008.
4. Within 20 days of the date of this Order, Big Sandy shall file with the Commission revised tariff sheets showing the rates approved herein.
