O R D E R

On October 30, 2008, the Commission issued an Order in this proceeding granting tw telecom of kentucky, llc ("tw telecom") a Certificate of Public Convenience and Necessity to enter into a franchise agreement with Lexington-Fayette Urban County Government to provide communications services. Upon its own motion, the Commission reviews the October 30, 2008 Order and finds a portion of that Order contained an error as to the correct corporate name of tw telecom. The first sentence of the October 30, 2008 Order incorrectly refers to tw telecom as "tw telecom, llc." The Commission finds that reference shall be corrected by this Order.

IT IS THEREFORE ORDERED, nunc pro tunc:

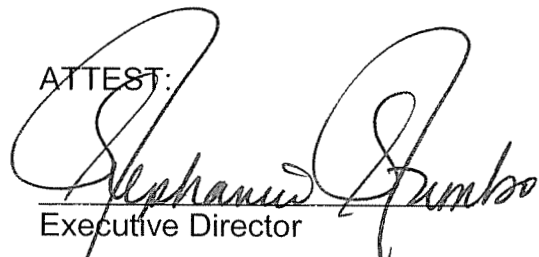
1. The first sentence of the October 30, 2008 Order is amended to state the correct corporate name of tw telecom as "tw telecom of kentucky, llc."
2. All other provisions of the October 30, 2008 Order shall remain in full force and effect.
