On October 22, 2008, West Carroll Water District ("West Carroll") filed an application to increase its nonrecurring charge for meter connections. Pursuant to 807 KAR 5:001, Section 2, Commission Staff rejected the application for filing purposes for its failure to comply with 807 KAR 5:001, Section 10(1)(b)-(e); 807 KAR 5:001, Section 8; and KRS 278.180.

On November 18, 2008, West Carroll advised the Commission in writing of its intent to withdraw its present application. Considering West Carroll's written request as a motion to withdraw its current application and close the present docket, the Commission finds that the motion should be granted.


IT IS THEREFORE ORDERED that:
