This is in reference to the Commission's order to extend the reporting time to respond to verifying that our customers have been adjusted or credited for any amounts in excess of the effective rate that the Commission had approved then revised because the City of Ashland had not applied for their rate increase.

We would like the Commission to know that this was a very time consuming task that our employees had to accomplish while doing their normal daily jobs. We had asked for extension of 60 days, which you kindly granted. We have credited 6699 customers for the amount of \$29,517.33 for the meter readings in January and February 2009.
