GRANTOR(s) for a good and valuable consideration, the receipt to which is hereby acknowledged, do hereby grant unto Big Sandy Rural Electric Cooperative Corporation, Paintsville, Ky., GRANTEE and to its successors or assigns the right of ingress and egress upon the lands of the GRANTOR(s), with the right to construct, reconstruct, operate, maintain, relocate, inspect, repair and remove on the below-described lands an electric power line or system and tele-communication line or system with all necessary poles and equipment, to cut and trim trees and shrubbery that may interfere with or threaten to endanger the operation, maintenance and removal of said lines or systems and to license, permit or otherwise agree to the joint use of occupancy of the poles, line or system by any other person, association or corporation, for electrification or tele-communication purposes.
The easement shall be 35 feet in width and shall be perpetual over, across and through the land of the GRANTOR(s) as described herein.
