The North Shelby Water Company respectfully requests that the COMMISSION allow us to make an adjustment in our rates in accordance with $807~\mathrm{KAR}~5:067~\mathrm{Purchased}$ Water Adjustment clause.

The Company has been told by its suppliers, Frankfort Electric and Water Plant Board that a \$0.0965 increase will take effect on November 30, 2008. The Company purchased 178,419,000 gallons from Frankfort between December 2007 and November 2008. The result of these increases is an increase to our rates of \$0.05 per 1,000 gallons. We propose to raise each gallonage block that amount.
