## PETITION FOR APPROVAL TO DEVIATE FROM RULE

Kentucky Utilities Company ("KU") petitions the Kentucky Public Service Commission ("Commission") to grant KU approval, pursuant to 807 KAR 5:011 § 14, to deviate from the Notice of Public Hearing requirement in the above-captioned proceeding because KU has substantially complied with the Commission's notice regulations. In support of this petition, KU states as follows:

- Pursuant to KRS 424.200, newspaper publication of rate change hearings must be 1. in accordance with the Commission's regulations.
- The Commission's regulations prescribe that newspaper publication of a rate 2. change hearing must occur in a newspaper of general circulation in the areas to be affected "one time not less than seven nor more than twenty-one days prior to the hearing." 807 KAR 5:011 § 8 (5).
- The purpose of the Commission's rate change notice regulations is to ensure that 3. members of the public have sufficient notice and a meaningful opportunity to participate, individually or through representative agencies, in this proceeding. As stated by the Kentucky Supreme Court:

Substantial compliance in regard to publication requirements has been authorized. The purpose of the statute is to allow the public an ample opportunity to become sufficiently informed on the public question involved.<sup>2</sup>

## **Publication of Notice**

- 4. On January 23, 2009, the Commission ordered KU to submit to an examination on the application of its fuel adjustment clause ("FAC") from November 1, 2006 through April 30, 2008. The hearing will be held on March 17, 2009.
- 5. In accordance with the Commission's notice regulations, KU contacted the Kentucky Press Association on February 12, 2009 to arrange for a Notice of Public Hearing to be published in 95 newspapers in KU's service areas during the time period February 24, 2009 to March 10, 2009.
- 6. KU's efforts notwithstanding, The *Liberty Casey County News*, a small weekly newspaper published in Liberty, Kentucky, published the notice on February 18, 2009, six days before the time period specified by the rule. At KU's request, notice was republished. Because the *Liberty Casey County News* only publishes on Wednesdays, the notice was republished on March 11, 2009, one day outside of the rule. <sup>3</sup>

## Request for Deviation from Rule

7. In view of the timely published notice KU has provided throughout the vast majority of the newspapers in its service territory – including the two newspapers of largest

circulation in the Commonwealth, the *Lexington Herald-Leader* and the *Louisville Courier-Journal*, and the efforts made by KU to ensure that timely notice was received, KU respectfully requests a deviation from the Commission's Notice of Public Hearing regulation with respect to the one instance of non-conformity cited above. Ninety-three newspapers,<sup>4</sup> whether the legally required newspapers or not, published timely notice. At KU's insistence, the one legally required newspaper that failed to publish timely notice ultimately published within one day of the rule.

- 8. As noted at the beginning of this Petition, the Kentucky Supreme Court has stated, "Substantial compliance in regard to publication requirements has been authorized. The purpose of the statute is to allow the public an ample opportunity to become sufficiently informed on the public question involved." KU respectfully submits that it has substantially complied with the Commission's notice regulations, therefore achieving their purpose, namely ensuring that the public has sufficient notice of the proceeding and a meaningful opportunity to participate, individually or through representative agencies. KU therefore respectfully requests the Commission to grant a deviation from its Notice of Public Hearing regulation, deeming KU's substantial compliance to be sufficient compliance with the regulation in this proceeding.
- 9. KU's request for deviation from the Commission's notice of public hearing regulation is similar to a request made to the Commission on January 9, 2009 and granted by the Commission on January 16, 2009 in the *Application of Kentucky Utilities Company for an Adjustment of Electric Base Rates*, Case No. 2008-00251.

WHEREFORE, Kentucky Utilities Company respectfully requests that, pursuant to 807 KAR 5:011 § 14, the Commission grant a deviation from its Notice of Public Hearing regulation, deeming KU's substantial compliance to be sufficient compliance with the regulation in this proceeding.


