I AM A CUSTOMER OF THE ROCKCASTLE /JACKSON CO. R.E.C.C. AND AM WRITEING THIS LETTER TO PROTEST THE UP COMEING RATE INCREASE FOR THE KY UTILIIES CO. WHO IS THE SUPPLYERS OF OUR ELECTRIC POWER. RECC BUYS OUR ELECTRIC POWER FROM K.U. AND THEN RESALES IT TO US. EVERY TIME K.U. GETS A RATE INCREASE THEY PASS IT ON TO US AND THEN WHEN R.E.C.C. GETS A RATE INCREASE THEY TOO PASS IT ON TO US. K.U. CUSTOMERS GET THEIR POWER AT A GOOD RATE WHILE WE AS R.E.C.C. CUSTOMERS GET THE SHAFT. MY ELECTRIC BILL REFELECTS A FUEL CHARGE FOR MAKING ELECTRIC, YET R.E.C.C. DOES NOT HAVE ANY GENERIATORS TO MAKE IT WITH. THEY BUY THE ELECTRIC. AND WE PAY TWO TIMES FOR THE SAME THING. THERE SHOULD BE ONELY ONE FUEL CHARGE; IT SHOULD BE TO THE SUPPLYER FROM THE PROVIDER. WE BELIEVE THE SUPPLIER INCURED THE ADDED EXPENCE, NOT THE PROVIDER. HAVE WE FORGOTTEN, THE COST OF FUEL HAS GONE DOWN, IT IS LOWER NOW THAN WHEN THEY FIRST GOT A FUEL CHARGE APPROVED. WE NEED TO STOP SOME OF THIS DOUBLE DIPPING.

THANK YOU FOR YOUR TIME. I AM ON A FIXED INCOME AND CAN NOT AFFORD MORE INCREASES. MY RETIREMENT CHECK DOES NOT GO UP ANY AND NEATHER DOES MY SOCIAL SECURITY. ONLY THING GOING UP IS THE UTILITIES AND MEDICARE PAYMENTS. WE NEED YOUR HELP
