ORDER

On December 19, 2008, West Shelby Water District ("West Shelby District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. West Shelby District purchases water from Shelbyville Municipal Water and Sewer Commission ("Shelbyville") and the Louisville Water Company ("Louisville").
- 2. Shelbyville notified West Shelby District that Shelbyville's wholesale water rate to West Shelby District would increase from \$1.73 per 1,000 gallons to \$1.83 per 1,000 gallons effective January 19, 2009. West Shelby District proposes to increase the water rates to its customers effective March 1, 2009.
- 3. West Shelby District's application contained a mathematical error in the purchased water factor and subsequently in the computation of the proposed rates.
- 4. During the 12 months ending November 30, 2008, West Shelby District purchased a total of 68,494,072 gallons of water from Shelbyville and a total of 203,606,000 gallons of water from Louisville and sold 254,685,100 gallons. The

increase in the cost of purchased water is \$6,849.41, resulting in a purchased water adjustment of \$0.03 per 1,000 gallons.

5. The purchased water adjustment of \$0.03 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. West Shelby District's proposed rates are denied.
- 2. The purchased water adjustment of \$0.03 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B are fair, just, and reasonable and are approved for services rendered on and after March 1, 2009.
- 3. Within 20 days of the date of this Order, West Shelby District shall file with the Commission revised tariff sheets showing the rates approved herein.
