To the COMMISSION:

The U.S. 60 Water District respectfully requests that the COMMISSION allow us to make an adjustment in our rates in accordance with 807 KAR 5:067 Purchased Water Adjustment clause.

The District has been told by its supplier, Frankfort Electric and Water Plant Board that a \$0.0465 increase will take effect on November 30, 2008. The Company purchased 156,444,400 gallons from Frankfort between December 2007 and November 2008. The result of these increases is an increase to our rates of \$0.06 per 1,000 gallons. We propose to raise each gallonage block that amount.

The District requests the COMMISSION to grant a deviation from the regulations and allow two purchase water adjustments in that we received two adjustments within 8 days of each other. We advertised this rate adjustment in the newspaper on December 19, 2008.
