To the COMMISSION:

The North Shelby Water Company respectfully requests that the COMMISSION allow us to make an adjustment in our rates in accordance with 807 KAR 5:067 Purchased Water Adjustment clause.

The Company has been told by its suppliers, Frankfort Electric and Water Plant Board that a \$0.283 increase will take effect on December 6, 2008. The Company purchased 178,419,000 gallons from Frankfort between December 2007 and November 2008. The result of these increases is an increase to our rates of \$0.13 per 1,000 gallons. We propose to raise each gallonage block that amount.
