Dear Director:

This letter and petition is in follow-up to our receiving high electric bills from Kentucky Power Company for the month of December-January, 2009, and the intended higher price rates they are trying to get passed in February, 2010.

We do understand that more electric should have been used during the 15 extremely cold days we just went through, but we believe the bill should not have doubled or tripled for a one month period of time. Also, many of us were without electric from December 18-December 25, 2009, with many other being without even longer. We also understand that the expenses endured by the electric company was extremely high for repairs due to the December storm, but we feel that we should not have to bear this costs, especially when everyone is suffering and recuperating from the storms themselves.

Many people are already struggling to pay their utilities and other living costs due to high prices everywhere. Many of these same people are poor and survive from government benefits, so they are already budgeting to the limit. The people with our government state that these benefit receivers do not get a cost of living raise this year since the costs of living never went up. (They must not buy any gas, groceries or pay utilities.)

We are asking your office to check into this matter and see if the electric company is doing right by the consumers using their services. Also, we want to make sure we are not being overcharged for these services. Also, could you please check into this new rate fee thing they are trying to get passed which will raise everyone's monthly electrical bill by at least \$50-\$100 per month.
