Dear Mr. Bellar:

Your letter to me along with your website addressed the needs to increase rates. These same sites don't provide information about KU's last five year profits. I would like to see this information published along with the claimed needs. I would assume that your needs to increase rates are directly proportional to reduction of profit margins.

Further the data on the attached spreadsheet was pulled directly from my KU bills. The data shows that since 2005 my cost per KWH has increased 133% in the last five years from \$.055197 to \$.073645. This represents an average yearly increase of 7.23%

As for cost of new infrastructure and capacity – your website indicates that new stations will be more efficient and cleaner. Should this not actually translate into lower cost per KWH that you could pass along to your customers?

I don't presume to know if you really "need" an adjustment or not, however I did want to voice my comments that:

- My net cost per KWH has, since 2005 increased 7.23% per year.
- I would ask you benchmark your rates against the best (yourself?), as opposed to those that are higher. (I could claim to be less overweight than a sumo wrestler, however my BMI is still a bit high)
- Do I really need Electric Company to spend money advertising on TV? Would a glossy insert with my bill not work? (From my next comment, the TV advertizing might be working)
- I am very pleased with KU's service. It is very reliable and safe. When we do have storms and loose power, the service response is great.
- I would prefer my rates not increase more than they already have.
