I am writing this letter on behalf of myself and my family to express deep anger for the proposal for E-On US (LG&E) to raise the residential electric and natural gas rates. In September of 2008, a natural disaster of unheard of proportions happened upon KY. Hurricane force winds wreaked havoc on our city and our livelihood. My home sustained over \$17000 in damages. We went without electricity for a month due to the damages. Five months later, yet another disaster struck us. The ice storm caused further damage to the home and we were without power for another week. E-On US is saying they need to raise our rates to recover money they lost during the natural disasters. This is 100% wrong. E-On US is a billion dollar company that is still making money every day, even during this recession because they have a monopoly on customers that have natural gas & electric service with them. My family is unable to call and disconnect service because we can't afford their service. The fair action for them to take would be the executives & shareholders should take a pay cut from the billions of dollars they make every year. Enclosed in this envelope is an article from the local newspaper dated February 3, 2010 noting the breakdown of the annual increases. What angers me the most is the residential increases are the greatest. I believe the mathematician that came up with these figures decided to raise the residential rates the most because they knew it was a guaranteed way to get the money back. Businesses lose money every day in this world and recoup their losses by cutting money back or changing policies. As a resident of Kentucky that has to have hot water to take a shower and a refrigerator to keep food cold, please do not allow a billion dollar company that is making money every day to raise our natural gas and electric bills.

Louisville Gas and Electric Company proposes to change the text of the following gas tariffs: Residential Gas Service Rate RGS, Volunteer Fire Department Rate VFD, Firm Commercial Gas Service Rate CGS, Firm Industrial Gas Service Rate IGS, As-Available Gas Service Rate AAGS, Firm Transportation Service Rate FT, Distributed Generation Gas Service Rate DGGS, Gas Transportation Service/Standby Rider TS, Pooling Service Rider PS-TS, Pooling Service Rider PS-FT, Excess Facilities Rider EF, Gas Supply Clause GSC, Demand Side Management Cost Recovery Mechanism DSM, School Tax Adjustment Clause, and the Terms and Conditions.

The foregoing rates reflect a proposed annual increase in electric revenues of approximately 12.1% and gas revenues of approximately 7.7% to Louisville Gas and Electric Company.

LG&E is proposing to increase the required Customer Deposit for residential electric customers served under Residential Rate RS from the current amount of \$135.00 to \$160.00 (19% increase), and proposes to decrease the required Customer Deposit for residential gas customers served under Residential Gas Service Rate RGS from the current amount of \$160.00 to \$115.00 (28% decrease). The Customer Deposit for combined gas and electric residential service, if required, would decrease from the current amount of \$295.00 to \$275.00 (7% decrease). LG&E does not propose to change the Customer Deposit amount required for non-residential electric customers served under General Service Rate GS, which is currently \$220.00 (0% increase).

The rates contained in this notice are the rates proposed by Louisville Gas and Electric Company; however, the Public Service Commission may order rates to be charged that differ from the proposed rates contained in this notice.

Notice is further given that any corporation, association, body politic or person with a substantial interest in the matter may by written request, within thirty (30) days after publication of the notice of the proposed rate changes, request to intervene. The motion shall be submitted to the Public Service Commission, 211 Sower Boulevard, P. O. Box 615, Frankfort, Kentucky 40601, and shall set forth the grounds for the request, including the status and interest of the party. Intervention may be granted beyond the thirty (30) day period for good cause shown. Any person who has been granted intervention may obtain copies of the application and any other filings made by the utility by contacting Lonnie E. Bellar, Vice President - State Regulation and Rates, Louisville Gas and Electric Company, 220 West Main Street, Louisville, Kentucky, 502-627-4830.

A copy of the application and testimony shall be available for public inspection at the offices of Louisville Gas and Electric Company or the Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky.
