## Quang:

This is a follow-up to the testimony of Sandy Novick given rather extemporaneously at last Thursday's hearing in Case No. 2009-00040. We want to make certain that Commission Staff and the intervenors understand that the implementation of the wholesale and retail rates will be coordinated and there will be no windfall to the distribution cooperatives if and when the wholesale increase becomes effective.

On the effective date both the increased wholesale rates and the retail flow through rates commence simultaneously. As explained by Mr. Novick the distribution cooperatives prorate their customer bills as of the effective date. The billing for the wholesale service comes at the first of the month (it is for the previous month's service) and is due and payable on the first working day after the 24th. However, due to cyclical billings of the distribution cooperatives, some retail customers will have bills payable before the first working day after the 24th, and some afterward. Thus, the benefit of the earlier collections will be offset by the lateness of the latter ones. Regardless of the timetable for the billings, both the wholesale increase and the retail flow through commence simultaneously and run concurrently.
