## REPLY TO RESPONSE TO OBJECTION OF EAST KENTUCKY NETWORK

Comes the Applicant, East Kentucky Network, LLC d/b/a Appalachian Wireless ("EKN"), by counsel, and for its reply to the response to objection of the Intervenor, Lee Etta Cummings, states as follows:

To set the record straight, this Applicant has not violated this Commission's order of May 8, 2009 by virtue of the letters sent by Gerald Robinette, EKN's General Manager dated May 20, 2009, and May 22, 2009.

These letters were sent in fact in response to the position of the Intervenor, Ms. Cummings, at the hearing in which she represented to this Commission and its representatives that her property was actively being considered as a site for a federal prison in Letcher County, but for the proposed tower. The remaining letter to Sapphire Coal Company was to put to rest any doubts raised by Ms. Cummings, again at the informal conference on this matter in which she stated that Sapphire would be unable to mine coal it had leased from her by reason of the tower location. Mr. Robinette's letters simply show that neither of the allegations as represented by Ms. Cummings at the informal conference are true.

Be that as it may, EKN, by counsel, hereby admits that such letters should not be considered in any manner as part of its response filed herein in connection with the order of May 8, 2009, and the Commission is invited to strike the same from the record as having been untimely submitted.

EKN expects, therefore, that the documents submitted by the Intervenor with her June 19, 2009 letter likewise be stricken in accordance with the Applicant's motion to strike the same as being untimely and submitted in violation of the Commission's order.

EKN intends in all respects to abide by this Commission's orders and to in all cases abide by the Commission's orders, expects the other parties to do the same, and expects the Commission to enforce its orders accordingly.
